The Lauderdale County Commission convened at the Lauderdale County Courthouse in the City of Florence, Alabama at 5:00 p.m. on the 22nd day of July, 2019. Chairman Pettus, upon declaration of a quorum being present, opened the meeting for the transaction of business.

The invocation and Pledge of Allegiance were delivered by Commissioner Garner.

Awards and Presentations:

Commissioner Hackworth moved, seconded by Commissioner Parker to approve a resolution acknowledging Barbara Jean Collum for fifty years of service with Lauderdale County. Commissioner Hackworth mentioned that Ms. Collum would be presented the resolution at an event on Friday, August 2nd, 2019. There being no further discussion and upon a vote taken, motion unanimously approved.

Public Comments on Agenda items: None

Commissioner Holmes moved, seconded by Commissioner Garner that all items listed on the regular business agenda be approved for immediate consideration. There being no discussion and upon a vote taken, motion unanimously approved. Agenda is herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Hackworth that the minutes of the last regular meeting of the Commission be approved for recording. There being no discussion and upon vote taken, motion unanimously approved.

Commissioner Holmes moved, seconded by Commissioner Garner to approve a resolution authorizing a petition filed by Mark Reid, developer of Cedarbrook II Subdivision, to accept the roads in the subdivision into the Lauderdale County Road System for maintenance. Commissioner Holmes addressed Eric Hill, Lauderdale County Road Engineer, to verify that the roads are in

compliance with all rules, regulations and standards required to be accepted into the County Road Maintenance Program. Mr. Hill stated that they are up to county specifications. There being no further discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Garner to approve a resolution authorizing renewal of a contract with Syscon for voting hardware maintenance, software license, maintenance and all support services for election-related activities. The contract is good for thirty-six months from August 1, 2019, through July 31, 2022. There being no discussion and upon a vote taken, motion unanimously approved.

The invoiced bills were audited, allowed, and ordered to be paid upon a motion by Commissioner Hackworth and seconded by Commissioner Holmes. Commissioner Holmes asked Eric Hill, Lauderdale County Road Engineer, about the Road Department increase to which Mr. Hill replied that the \$950,000 was budgeted funds and the paving project was close to completion. Commissioner Parker confirmed that the material price was this year's bid price and was continuing a bid already in place. There being no further discussion and upon a vote taken, motion unanimously approved.
