Chairman Pro-Tem, Fay Parker, upon declaration of a quorum being present, opened the meeting for the transaction of business.

Commissioner Hackworth moved, seconded by Commissioner Garner that all items listed on the regular business agenda be approved for immediate consideration. There being no discussion and upon a vote taken, motion unanimously approved. Agenda is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Garner that the minutes of the last regular meeting of the Commission be approved for recording. There being no discussion and upon vote taken, motion unanimously approved.

Commissioner Garner moved, seconded by Commissioner Holmes to approve a resolution that authorizes the Lauderdale County Commission to pay all yearly dues and fees for all County departments and various officials for the 2019-2020 upcoming budget year. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein approved and made part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Holmes to approve a resolution to authorize the weekend of February 21, 2020, to be used as a Severe Weather Preparedness exemption of state sales and tax for non-commercial purchases related to severe weather preparedness. The Lauderdale County Board of Education has given their approval.

There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein approved and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Garner to approve a resolution to authorize a Federal Grant in the amount of forty-five thousand two hundred ninety-six dollars for the Lauderdale County Emergency Management Agency. This grant is to be expended only for purposes and activities that will strengthen emergency management programs. George Grabryan, EMA Director, will administer the grant. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Garner moved, seconded by Commissioner Hackworth to approve a resolution to authorize a Supplemental Federal Grant in the amount of twelve thousand dollars for the Lauderdale County Emergency Management Agency. This grant is to be expended only for purposes and activities that will strengthen emergency management programs. George Grabryan, EMA Director, will administer the grant. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Garner to approve a resolution to authorize the Lauderdale County Courthouse to follow the State of Alabama holiday schedule. The Lauderdale County Courthouse will be closed for Thanksgiving on November 28th and 29th, 2019, and closed for Christmas on December 24th and 25th, 2019. The Lauderdale County Commission will not have a Commission Meeting on December 23rd, 2019, due the holiday and this meeting will be cancelled. The Lauderdale County Commission does give their approval for the Lauderdale County Administrator to pay all regular bills due at that time. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Garner to approve a resolution to authorize the Lauderdale County Commission, pursuant to current Alabama Law, to not allow removal, relocation, alteration, renaming or other disturbance of any monument located at the Lauderdale County Courthouse as well as allowing no new monuments to be put upon the Lauderdale County Courthouse exterior. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Garner to appoint Janyce Fadden to the Shoals Economic Development Authority Board, effective immediately and expiring September 30th, 2022. There being no discussion and upon a vote taken, motion unanimously approved.

Commissioner Garner moved, seconded by Commissioner Holmes to reappoint Greg Ezell to the Shoals Economic Development Authority Board, effective immediately and expiring September 30th, 2022. There being no discussion and upon a vote taken, motion unanimously approved.

Commissioner Hackworth moved, seconded by Commissioner Garner to approve Family Medical Leave for one Lauderdale County Sheriff Jail Corrections Deputy. All medical paperwork is in order and leave will be from September 13th, 2019 through November 7th, 2019. There being no discussion and upon a vote taken, motion unanimously approved.

Commissioner Garner moved, seconded by Commissioner Holmes to approve out-of-state travel for Chairman Pettus to travel to Washington, D.C., for a conference with President Trump and other County Commissioners. The trip will be October 15 - 18, 2019. There being no discussion and upon a vote taken, motion unanimously approved.

Commissioner Holmes moved, seconded by Commissioner Hackworth to approve out-of-state travel for Sheriff's Department employees, Sam Bishop and Ricky Young, to travel to Franklin, TN, for a four-day REID Training Conference for Investigative Interviewing and Advanced Interrogation Techniques. The trip will be November 11 - 21, 2019. There being no discussion and upon a vote taken, motion unanimously approved.

In compliance with bid laws of the State of Alabama, sealed bids were advertised for Bid No. LA 2020-1 "Various Print Bids". Bids were received and publicly read aloud on October 11th, 2019. Chairman Pro-Tem, Fay Parker, asked County Administrator, Brenda Bryant, for her recommendation. Ms. Bryant stated that the only bid was received from Printers & Stationers. She recommends we purchase Sheriff envelopes, with no price break, at a cost of five hundred ninety-eight dollars for a quantity of ten thousand. Commissioner Garner moved to accept the bid and Commissioner Hackworth seconded. There being no further discussion and upon a vote taken, motion unanimously approved. Bid is awarded to Printers & Stations of Florence, Alabama. Bid tabulation sheet is recorded and made part of these minutes

NOW THEREFORE BE IT RESOLVED by the Lauderdale County Commission that it does herein grant the exemption of County sales and use taxes on purchases covered by Act No. 2012-256 during the last full weekend of February, 2020, beginning at 12:01 a.m. on Friday, February 21st, 2020 and ending at 12:00 midnight on Sunday, February 23rd, 2020, and
