Chairman Pettus, upon declaration of a quorum being present, opened the meeting for the transaction of business.

The invocation and Pledge of Allegiance were delivered by Chairman Pettus.

Commissioner Holmes moved, seconded by Commissioner Garner that all items listed on the regular business agenda be approved for immediate consideration. There being no discussion and upon a vote taken, motion unanimously approved. Agenda is herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Hackworth that the minutes of the last regular meeting of the Commission be approved for recording. There being no discussion and upon vote taken, motion unanimously approved.

Commissioner Parker moved, seconded by Commissioner Garner to approve a resolution to select and designate the Lauderdale County Depositories for the placing therein of the Lauderdale County Funds for the following calendar year. The depositories that were chosen have agreed to secure all funds according to the provisions of the Security of Alabama Funds Enhancement or SAFE Program. This requires any bank in the SAFE Program to meet the requirements to be designated as a qualified public depository. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein approved and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Garner to approve a resolution to authorize an appropriation to the Shoals Area Chamber of Commerce Foundation in the amount of three hundred twenty-five dollars to be paid from the Tourism Fund. There being no discussion

and upon a vote taken, motion unanimously approved. Resolution is herein approved and made part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Parker to approve a resolution to authorize another year with Southern Health Partners for medical care for inmates at Lauderdale County Detention Center. The renewal consists of a three-percent increase to the base annualized fee for a monthly charge of thirty-nine thousand two hundred fifty-one dollars and fifty-five cents and an annual outside cost pool limit, which remains unchanged, at eighty-four thousand dollars. The agreement will be renewed for a period of one year to be effective January 16th, 2020, and expire January 15th, 2021. There being no discussion and upon a vote taken, motion unanimously approved. Resolution and agreement are herein approved and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Parker to reappoint Gary Wilkinson, Jamy Poss and Judge Gil Self to the Law Library Advisory Committee. Terms will begin immediately and expire January 2023. There being no discussion and upon a vote taken, motion unanimously approved.

In compliance with bid laws of the State of Alabama, sealed bids were advertised for Bid No. LA 2020-1 "Various Print Bids". Bids were received and publicly read aloud on November 8th, 2019. Chairman Pettus asked Lauderdale County Administrator, Brenda Bryant, for her recommendation. Ms. Bryant stated that two bids were received form Herald Printing and Printers & Stationers, both of Florence, Alabama. She recommends we purchase fifteen Detention Center receipt books at a cost of two hundred fifty-five dollars and sixty-five cents from the low bidder, Herald Printing. Commissioner Hackworth moved to accept the bid and Commissioner Parker seconded. There being no further discussion and upon a vote taken, motion unanimously approved. Bid is awarded to Herald Printing of Florence, Alabama. Bid tabulation sheet is recorded and made part of these minutes.

The invoiced bills were audited, allowed, and ordered to be paid upon a motion by Commissioner Parker and seconded by Commissioner Holmes. There being no discussion and upon a vote taken, motion unanimously approved.

This act requires any bank in the State of Alabama accepting public fund deposits to meet the requirements to be designated as a qualified public depository. The Qualified Public Depositories will pledge eligible collateral to the State Treasurer on all public deposits creating a collateral pool.
