Chairman Pettus, upon declaration of a quorum being present, opened the meeting for the transaction of business.

The invocation and Pledge of Allegiance were delivered by Commissioner Garner.

Commissioner Hackworth moved, seconded by Commissioner Parker that all items listed on the regular business agenda be approved for immediate consideration. There being no discussion and upon a vote taken, motion unanimously approved. Agenda is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Garner that the minutes of the last regular meeting of the Commission be approved for recording. There being no discussion and upon vote taken, motion unanimously approved.

Commissioner Parker moved, seconded by Commissioner Garner to approve a resolution to authorize the Lauderdale County Commission to host a luncheon for the Alabama State Legislature. This time together allows the opportunity to discuss local Lauderdale County issues and keeps an open line of communication with our local State Legislatures. The luncheon was catered by Cracker Barrell and had a total cost of two hundred sixty-eight dollars and seventy-two cents. There being no discussion and upon a vote taken, motion unanimously approved.

Commissioner Holmes moved, seconded by Commissioner Parker to approve a resolution to allow the Lauderdale County Road Department to begin using the Acknowledgement of Culvert/Pipe Ownership Form. This form will be used when certain driveway conditions make it necessary to install a culvert/pipe on personal property that joins Lauderdale County's right-ofway. The use of this form requires the property owner to follow County policy when work is needed and the property owner must sign the form before work is performed. There being no

discussion and upon a vote taken, motion unanimously approved. Resolution and form are herein approved and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Hackworth to approve a resolution to authorize Lauderdale County Road Department Engineer, Eric Hill, to cancel the current contract with Cypress Contracting, LLC, for Bid 2019-11, "Reinforced Concrete Bridge Culvert on County Road 54 over Bumpass Creek" due to inability to complete in the time allowed for the project. Mr. Hill requests to award the bid to the second lowest bidder, Glasgow Construction, Inc., of Guin, Alabama. Commissioner Holmes confirmed with County Attorney, Chris Smith, that all county and state guidelines were followed in cancelling the previous contract and awarding to the new contractor. Mr. Smith confirmed that we have adhered to all policies and procedures regarding contract changes. There being no further discussion and upon a vote taken, motion unanimously approved. Resolution and any budget amendment necessary are herein approved and made part of these minutes.
