The Lauderdale County Commission convened at the Lauderdale County Courthouse in the City of Florence, Alabama, at 5:00 p.m. on the 10th day of February, 2020. The meeting was called to order by the Chairman of the Lauderdale County Commission, Danny Pettus. Upon roll call, the following members answered present:

Chairman Pettus, upon declaration of a quorum being present, opened the meeting for the transaction of business.

The invocation and Pledge of Allegiance were delivered by Chairman Pettus.

Awards and Presentations:

Commissioner Holmes moved, seconded by Commissioner Parker to authorize a resolution recognizing Lauderdale County Sheriff Corrections Deputy, Sarah Creasy, for her efforts in completing the necessary program requirements from the National Institute of Jail Operations through the Alabama Jail Training Academy. Lauderdale County Sheriff, Rick Singleton, presented Ms. Creasy with a copy of the resolution, a certificate and commemorative pin to acknowledge her significant contributions and commitment to Lauderdale County. Sheriff Singleton commended her on her work ethic and the outstanding job she does for the County. There being no further discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Public Comments on Agenda items: None

Commissioner Garner moved, seconded by Commissioner Hackworth that all items listed on the regular business agenda be approved for immediate consideration. There being no discussion and upon a vote taken, motion unanimously approved. Agenda is herein recorded and made part of these minutes.

Commissioner Garner moved, seconded by Commissioner Parker that the minutes of the last regular meeting of the Commission be approved for recording. There being no discussion and upon vote taken, motion unanimously approved.

Commissioner Holmes moved, seconded by Commissioner Hackworth to approve a resolution to help sponsor the upcoming Alabama High School Athletic Association North

Regional Softball Tournament with a donation of five thousand dollars to the City of Florence Parks & Recreation Department. These funds will be paid from the tourism fund and any budget amendment needed for this contribution is herein approved. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Garner to approve a resolution to authorize a letter of agreement with Regional Care Hospital Partners (RCHP), Lauderdale County, the City of Florence, and the Healthcare Authority of Lauderdale County. This agreement addresses the demolition of Eliza Coffee Memorial (ECM) Hospital and the deeding of the property to Lauderdale County and the City of Florence. The demolition of the hospital has been completed and RCHP wishes to move forward with the deeding process. All rights and obligations of all parties are set out in a new letter agreement to be executed after proper authorization and said agreement is in the best interest of the citizens of Lauderdale County. Commissioner Holmes stated that this agreement stipulates the usage of this property for single family residential development. There being no further discussion and upon a vote taken, motion unanimously approved. Resolution is herein approved and made part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Parker to approve out-of-state travel that Lauderdale County Sheriff, Rick Singleton, has requested. Sheriff Singleton will attend the 2020 National Sheriff Association Annual Conference in Tampa, Florida from June 21st, 2020 through June 25th, 2020. There being no discussion and upon a vote taken, motion unanimously approved.

In compliance with bid laws of the State of Alabama, sealed bids were advertised for Bid No. LA 2020-1 "Various Print Bids". Bids were received and publicly read aloud on February 7th, 2020. Chairman Pettus asked Lauderdale County Administrator, Brenda Bryant, for her recommendation. Ms. Bryant stated that the only bid was received from Printers & Stationers of Florence, Alabama. She recommended we purchase the price-break cost of thirty-nine dollars for four hundred business cards for the Reappraisal Department. She also recommended no price-break on the remaining items for a cost of five hundred thirty-nine dollars for twelve thousand five hundred window envelopes for the Reappraisal Department and one hundred eighteen dollars for twenty-five hundred printed envelopes for the Revenue Department. Commissioner Holmes moved, seconded by Commissioner Garner, to follow Ms. Bryant's recommendation. There being no further discussion and upon a vote taken, motion unanimously approved. Bid is awarded to Printers & Stationers of Florence, Alabama. Bid tabulation sheet is recorded and made part of these minutes.

In compliance with bid laws of the State of Alabama, sealed bids were advertised for Bid 2020-7 "Gasoline and On-Road Diesel Fuel". Bids were received and publicly read aloud on February 4th, 2020. Chairmen Pettus asked Lauderdale County Road Department Engineer, Eric Hill, for his recommendation. Mr. Hill stated that the lowest bid for diesel fuel was received from Tatum Oil Company of Sheffield, Alabama, at a cost of .0345 per gallon and the lowest bid for gasoline was received from Petroleum Traders Corporation of Fort Wayne, Indiana, at a cost of .0313 per gallon. Mr. Hill recommends we split the bid between these two vendors for the lowest price on each item. Commissioner Garner moved, seconded by Commissioner Holmes, to follow Mr. Hill's recommendation. There being no further discussion and upon a vote taken, motion unanimously approved. Bid for diesel fuel is awarded to Tatum Oil Company of Sheffield, Alabama, and the bid for gasoline is awarded to Petroleum Traders Corporation of Fort Wayne, Indiana. Bid tabulation sheet is recorded and made part of these minutes.

The invoiced bills were audited, allowed, and ordered to be paid upon a motion by Commissioner Hackworth and seconded by Commissioner Parker. There being no further discussion and upon a vote taken, motion unanimously approved.
