Chairman Pettus, upon declaration of a quorum being present, opened the meeting for the transaction of business.

The invocation and Pledge of Allegiance were delivered by Commissioner Hackworth.

Awards and Presentations:

Commissioner Parker moved, seconded by Commissioner Hackworth to approve a resolution recognizing retiring employee, Clarence Roach, a driver for the Lauderdale County Road Department for over twenty-nine years. Chairman Pettus read the resolution that commended Mr. Roach for his years of service, dedication and commitment to Lauderdale County. There being no discussion and upon a vote taken, motion unanimously approved.

Public Comments on Agenda items: None

Commissioner Holmes moved, seconded by Commissioner Garner that all items listed on the regular business agenda be approved for immediate consideration. There being no discussion and upon a vote taken, motion unanimously approved. Agenda is herein recorded and made part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Parker that the minutes of the last regular meeting of the Commission be approved for recording. There being no discussion and upon vote taken, motion unanimously approved.

Commissioner Parker moved, seconded by Commissioner Garner to approve a resolution to pay the property insurance premium for the current year. The Travelers Insurance policy renews March 1<sup>st</sup>, 2020, and will be effective until March 1<sup>st</sup>, 2021. Premium for Property Insurance is forty-nine thousand seven hundred forty-nine dollars, Commercial Equipment is six thousand three hundred eighteen dollars, Heavy Vehicle Physical Damage is thirty-five thousand two hundred eleven dollars, Cyber Liability four thousand five hundred twenty dollars. The total premium for all coverage is ninety-five thousand seven hundred ninety-eight dollars. There being no discussion

and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Parker to approve a resolution to authorize the Lauderdale County Sheriff's Department to amend the department's budget for the current fiscal year to increase line item for vehicles in the amount of twenty-five thousand dollars and to increase line item for equipment in the amount of fifteen thousand dollars. This budget amendment is necessary as a result of the unavailability of Ford SUV's due to manufacturing issues at Ford Motor Company. Comparable vehicles manufactured by Chevrolet will be purchased in order for the department to maintain a fully operation fleet. There being no discussion and upon a vote taken, motion unanimously approved. Resolution and budget amendment are herein approved and made part of these minutes.

Commissioner Garner moved, seconded by Commissioner Holmes to approve a resolution to authorize a change in rates for Wheeler Park. Camping Rate will be fifteen dollars per day for campers with a reduced rate of ten dollars per day for senior citizens age sixty and over. Waste Disposal Rate for non-campers will be five dollars per occurrence. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Hackworth to approve a resolution to authorize the Lauderdale County Solid Waste Department to enter into an agreement with Tarkett USA, Inc. of Florence, Alabama. The agreement is for disposal of rubbish and waste at the new bulk hauler rate of fifteen dollars per ton with a minimum annual disposal weight requirement of twenty thousand tons. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Garner to approve a resolution to authorize Florence-Lauderdale Emergency Management Agency to take ownership of ten radiological detection devices from the Alabama Emergency Management Agency. The Alabama Department of Public Health will continue to support the calibration and testing of these devices. The Radiation Detection Units include eight Ludlum Model 14C (serial numbers 206365, 206388, 206341, 206369, 204545, 206290, 204544 and 206466) and two transportable monitors (Model TPM-903 serial number 903127 and Model TPM-903B serial number 258195). There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Holmes to approve a resolution to authorize Shoals Ambulance to continue a second year of awarded Bid No. LA 2019-6 "Advance Life Support Emergency Medical Treatment and Transportation Service" with the current policies and provisions provided in the original bid. The service contract is a joint contract with the City of Florence and the Commission will seek the continued support of the City of Florence for the upcoming contract renewal period. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Hackworth, seconded by Commissioner Parker, to approve a resolution to authorize changes to the upcoming Commission Meeting and Work Session schedules in consideration of upcoming holidays as follows:

- The regularly scheduled meeting of Monday, April 27<sup>th</sup>, 2020, will be moved to Tuesday, April 28<sup>th</sup>, 2020, at 5:00 p.m. due to the Confederate Memorial Day holiday.
- The regularly scheduled meeting of Monday, May 25<sup>th</sup>, 2020, will be moved to Tuesday, May 26<sup>th</sup>, 2020, at 5:00 p.m. due to the Memorial Day holiday.

There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Chairman Pettus asked Lauderdale County Administrator, Brenda Bryant, for her recommendation. Ms. Bryant stated that bids were received from Printers & Stationers and Herald Printing, both of Florence, Alabama. She recommended we purchase twenty-five thousand white intake cards for the Detention Center from the lowest bidder, Herald Printing, at a cost of four hundred thirty-one dollars and fifty cents. Commissioner Holmes moved, seconded by Commissioner Parker, to follow Ms. Bryant's recommendation. There being no discussion and upon a vote taken, motion unanimously approved. Bid is awarded to Herald Printing of Florence, Alabama. Bid tabulation sheet is recorded and made part of these minutes.

In compliance with bid laws of the State of Alabama, sealed bids were advertised for Bid No. LA 2020-3 "License Dept. Drive-Thru". Bids were received and publicly read aloud on February 27th, 2020. Chairman Pettus asked Lauderdale County Administrator, Brenda Bryant, for her recommendation. Ms. Bryant stated that bids were received King & Associates General Contractors of Muscle Shoals, Alabama, and Pierce & Allred Construction of Florence, Alabama. She recommended we go with the lowest bidder, Pierce & Allred Construction, at a cost of sixty-eight thousand forty-two dollars and ninety-one cents. Commissioner Hackworth moved, seconded by Commissioner Parker, to follow Ms. Bryant's recommendation. Commissioner Holmes asked if the low bidder was a qualified bidder, meeting all specification requirements, and Ms. Bryant confirmed they had indeed met the requirements to be considered for the bid award. There being no further discussion and upon a vote taken, motion unanimously approved. Bid is awarded to Pierce & Allred Construction of Florence, Alabama. Bid tabulation sheet is recorded and made part of these minutes.

In compliance with bid laws of the State of Alabama, sealed bids were advertised for Bid No. 2020-9 "Bridge Repairs on CR 85 over Cypress Creek". Bids were received and publicly read aloud on March 5<sup>th</sup>, 2020. Chairman Pettus asked Lauderdale County Engineer, Eric Hill, for his recommendation. Mr. Hill stated that the only bid was received from Shotcrete of America of Florence, Alabama, at a cost of forty-two thousand five hundred twenty-five dollars. He recommended we award the bid to Shotcrete of America. Commissioner Parker moved, seconded by Commissioner Hackworth, to follow Mr. Hill's recommendation. There being no discussion and upon a vote taken, motion unanimously approved. Bid is awarded to Shotcrete of America of Florence, Alabama. Bid tabulation sheet is recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Garner to appoint Steve McEachron to the Florence-Lauderdale Farmer's Market Board. Term will begin immediately and expire March 9<sup>th</sup>, 2023. Commissioner Holmes asked Lauderdale County Administrator, Brenda Bryant if there were any comments from existing Farmer's Market board members regarding this appointment and Ms. Bryant said everyone involved was pleased with this selection. There being no further discussion and upon a vote taken, motion unanimously approved.

Commissioner Holmes moved, seconded by Commissioner Hackworth to appoint Shana Thompson to the Floodplain Review Board. Term will begin immediately and expire March 9<sup>th</sup>, 2025. There being no discussion and upon a vote taken, motion unanimously approved.

The invoiced bills were audited, allowed, and ordered to be paid upon a motion by Commissioner Garner and seconded by Commissioner Parker. Commissioner Holmes asked County Administrator, Brenda Bryant, if the thirty-one thousand forty-two dollars for elections would be the total cost for the recent election. Ms. Bryant stated that each election normally costs around forty thousand dollars so there are a few more charges to be added to the amount upon completion of all processes related to the election. Ms. Bryant also mentioned that funds are used from the general fund for elections and some costs are refunded from the state once all related bills are paid. There being no further discussion and upon a vote taken, motion unanimously approved.
