The Lauderdale County Commission convened at the Lauderdale County Courthouse in the City of Florence, Alabama, at 5:00 p.m. on the 22nd day of June, 2020. The meeting was called to order by the Chairman of the Lauderdale County Commission, Danny Pettus. Upon roll call, the following members answered present:

Chairman Pettus, upon declaration of a quorum being present, opened the meeting for the transaction of business.

The invocation and Pledge of Allegiance were delivered by Commissioner Parker.

Awards and Presentations: None

Public Comments on Agenda items: None

Commissioner Hackworth moved, seconded by Commissioner Garner that all items listed on the regular business agenda be approved for immediate consideration. There being no discussion and upon a vote taken, motion unanimously approved. Agenda is herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Holmes that the minutes of the last regular meeting of the Commission be approved for recording. There being no discussion and upon vote taken, motion unanimously approved.

Commissioner Garner moved, seconded by Commissioner Holmes to approve a resolution to authorize the temporary, emergency relocation of two polling locations due to COVID-19 and social distancing concerns. The Anderson Town Hall location will be moved to the Anderson Gym, located at 6 School Road in Anderson, Alabama. The Rogersville Senior Center location will be moved to the First Baptist Church located at 222 College Street in Rogersville, Alabama. Commissioner Holmes stated that both of these temporary locations are very close, in proximity, to the original polling locations and allowable by the Attorney General. Commissioner Holmes also requested they be advertised in the East Lauderdale News for two weeks prior to the election. There being no further discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Holmes to approve a resolution to allow Judge Motlow to contract James Perdue as an election worker. Mr. Perdue would assist Judge Motlow in handling local, county, state and federal elections at a rate of thirty dollars per hour plus expenses. There being no discussion and upon a vote taken, motion unanimously approved. Resolution and contract are herein recorded and made part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Garner to approve a resolution to authorize the Lauderdale County Commission to purchase two lots at 1612 and 1614 State Street in Florence, Alabama. This property and the buildings located on the property will be used to store equipment and supplies for multiple county office including EMA, the Road Department, the Sheriff's Department and General Maintenance. The cost of the properties is two hundred thousand plus closing costs and the property is currently valued at three hundred forty thousand dollars. Necessary repairs are estimated at two hundred thousand dollars and are approved for this amount. The money for the property will be paid from the Lauderdale County General Fund. Necessary repairs will be paid from the Alabama Trust Capital Improvement Funds. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Parker to approve a resolution to discontinue the waiver currently in place for all fees charged for mail and credit card transactions for items processed by Probate, Revenue and License Departments. These fees were temporarily waived due to COVID-19 and as of July 1st the waiver will be discontinued. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Garner to approve a resolution to enter into a contract with Volkert, Inc. of Birmingham, Alabama, for services in connection with the Lauderdale County Work Development Center project. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Garner moved, seconded by Commissioner Hackworth to approve appointment of Fay Parker to the 911 Board to replace D.C. Thornton, effective immediately and expiring on June 22nd, 2024. There being no discussion and upon a vote taken, motion unanimously approved.

Commissioner Hackworth moved, seconded by Commissioner Garner to approve reappointment of Dr. George Makowski, Kitty Cox and Lee Freeman to the Lauderdale County Cemetery Rehabilitation Authority Board with all appointments expiring June 30th, 2022. There being no discussion and upon a vote taken, motion unanimously approved.

In compliance with bid laws of the State of Alabama, sealed bids were advertised for Bid No. 2020-11 "Reinforced Concrete Bridge on 291 over Lindsey Creek". Bids were received and publicly read aloud on June 16th, 2020. Chairman Pettus asked Lauderdale County Engineer, Eric Hill, for his recommendation. Mr. Hill stated that four bids were received and he recommends the lowest bidder for the job, Shotcrete of America, at a cost of two hundred ten thousand seven hundred eighty dollars and five cents. Commissioner Parker moved, seconded by Commissioner Hackworth, to follow Mr. Hill's recommendation. There being no discussion and upon a vote taken, motion unanimously approved. Bid is awarded to Shotcrete of America of Florence, Alabama. Bid tabulation sheet is recorded and made part of these minutes.

In compliance with bid laws of the State of Alabama, sealed bids were advertised for Bid No. LA 2020-9 "Refurbish Garbage Truck". Bids were received and publicly read aloud on June 18th, 2020. Chairman Pettus asked Lauderdale County Solid Waste Manager, Tom Smith, for his

recommendation. Mr. Smith recommended we go with the only bidder, McNeilus Company, at a cost of forty-one thousand eight hundred seventy-nine dollars and fifty-four cents. Commissioner Holmes moved, seconded by Commissioner Parker, to follow Mr. Smith's recommendation. There being no discussion and upon a vote taken, motion unanimously approved. Bid is awarded to McNeilus Company of Hoover, Alabama. Bid tabulation sheet is recorded and made part of these minutes.

The invoiced bills were audited, allowed, and ordered to be paid upon a motion by Commissioner Parker and seconded by Commissioner Garner. Commissioner Holmes asked County Engineer, Eric Hill, if most of the road expense was due to paving and reimbursable by Rebuild Alabama. Mr. Eric confirmed that much of it was for paving and repair of roads including Middle Road, Huntsville Road, and County Road 30. There being no further discussion and upon a vote taken, motion unanimously approved.

Public Comment Period:

Chairman Pettus opened the public comment period by presenting a letter from the United Daughters of the Confederacy regarding the confederate monument located on the grounds of the Courthouse. Chairman Pettus stated that it has been determined the monument was not given to Lauderdale County but given to the City of Florence and the City would be responsible for the monument.

James David Carson of 29 Auburn Street in Florence stated that there needs to be transparency from our elected officials who we need to hear from rather than the radical activist groups who are making lives miserable. He also stated that power is not what you have but what others think you have.

Reverend Billy Ray Simpson of Florence stated that white supremacy is not making America great again and the dead need to be buried in the cemetery. He further stated that to prove the halls of justice and its representatives are not racist, the statue needs to be moved as it symbolizes racism.

Amanda German of Greenhill stated that, as a granddaughter of immigrants from the Soviet Union, she understands that the biggest bully is the mob and yielding to the mob will be a lifelong process once it begins. She further stated that this is not about removing a monument.

- E. Bridges from Florence stated that there is bullying going on today just as it did years ago and we cannot pray and pledge allegiance to a flag and talk about being indivisible with liberty and justice for all without honoring that for all people.
- L. Murphy from Florence stated that the statue represents terroristic violence against citizens and needs to be removed.

Mr. Watson of Pine Street in Florence stated that he is with Single Lock Records and as a person in the music industry he has seen black and white come together without conflict in producing music, the soundtrack of our lives and what The Shoals is known for around the world. He further stated that the statue brings nothing of value into our community and we need to focus on what does.

Charlie Hardin of Florence stated that there is confusion about what the Civil War was about and that no one died for another's freedom, only money.

Cayla Sloan of Florence stated that the effects of the statue are discriminatory and we need to remove a distraction that does not promote a diverse and welcoming community. She further stated that we need to consider revenue and reputation in making this decision and not let the past define us and stand on the right side of history.

Mr. Johnson from Killen stated that removing the monument is only the beginning and there is no end once you let it begin.

K.C. Roberson, Commander, Sons of Confederate Veterans of Florence stated that the monument is a war memorial for local soldiers who died for their beliefs and stands in memory of the confederate dead from 1861-1865. He further stated that the grieving families, friends and community appreciate this for what it represents and we do not want to take away history.

Steven Bowen stated that he grew up here but has spent recent years in Colorado near to progressive issues in our nation and believes we need to be aware of the pain associated with the monument for those whose ancestors didn't only die but were erased and we should not continue this offense.

Camille Bennett of Florence stated that she has felt invisible during this meeting since she was not called upon earlier to speak and feels dehumanized in this moment and, as a person trained in discipline and non-violence, it is not about bullying anyone. She further stated that anyone who can't move forward in this moment is a coward and we all need to move on in peace, harmony and racial equity.

Alecia Kelly of Florence stated that the insulting games being played by our elected officials and lack of action regarding the monument is hypocritical to the Christian values expressed by those same representatives. She further stated that ignorance of the law is no excuse to put off this decision and it is their job to find out the answers and be resolute and steady in their leadership for the greater good of this community.

Elaine Mokwunye stated that the monument represents only some and not all of our citizens and that everyone matters. She thanked Mr. Holmes for attempting to put this on the agenda at the last meeting and is disappointed to know that it is still not on the agenda these weeks later. She stated that she expected more of our Commissioners.

Mr. Flippo of Killen stated that the statue represents one race and has a meaning and purpose of hate and injustice. He further stated there should not be a debate and we need to stop oppression and take it down and be a part of progressive change.

Mr. Murphy of Florence stated that he agrees with Camille Bennett and supports the removal of the statue and feels it is necessary for the greater good of the community to remove this monument which represents white supremacy and it needs to be relocated and preserved at the new location.

John Bowen of 818 Prospect Street in Florence made reference to the statue and it representing oppression and its presence bringing about violence and wants it removed.

Katie Randall of Chestnut Street in Florence stated that as a preservation professional she understands the importance of history and monuments but that this monument represents a false narrative. She further stated that if breaking the law is the main concern here that good men and women throughout history have defied bad laws for the greater good and we owe it to our children to be better stewards of what has been entrusted to us. She also stated that a 5-year old child can understand that if something hurts his friend's feelings and you can do something about it you should.

Aaron Alexander of Florence respectfully implored Chairman Pettus and Commissioner Holmes, as Christian men, to promote unity and peace and consider the opinions of the citizens who are truly offended by what this statue represents and prayerfully make this decision.

Melody Platt of Florence stated that she regrets moving here some two years ago and questions the ideals her children may learn from this sort of representation. She further asked the Commissioners to honor the perspective of the community and remove the statue. She further warned of possible economic repercussions if the monument is not removed and people do not want to be a part of this community as a result.

Kristen Rogers of Florence stated that the statue is a symbol of hate and not love and needs to be removed.

Ricky Johnson stated that we are all God's children and he means no disrespect when he says this statue only represents the dead – not hate, not race - but the dead who fought and left behind fatherless sons and daughters as a result of their commitment to this country. He further stated that the statue is similar to a tombstone that only marks the dead and does not represent who they were or what they did.

Robert Baxter of Florence stated that he is from Austin, Texas, but loves Florence and is proud to live in this area except for what this statue represents. He further stated that it may represent the dead, but only the white man. He said we need to be malleable and change and not hold on to a comfort that no longer has a place in our society. He stated that we need to pay attention to this new information and realize that this statue hurts people and we need to move it to the soldier's rest in the cemetery and be done.

Lori Gibbons of Florence thanked the Commission for hearing the grievances stated here today and asked that we be on the right side of history and make the decision to move the monument. She further stated that our country is in the midst of change and we need to change with it.

Kevin Potter of Florence stated that there are two types of mistakes people can make – those of the head and those of the heart – knowing something is wrong and doing it anyway or knowing what to do and not doing it. He further stated that we have things to be proud of and we have a place for this monument – the soldiers rest in the cemetery – and we need to put it in its proper place.

Tyler Young of Florence stated that this monument, where it currently stands, is a negative symbol of injustice and needs to be moved to a proper place of remembrance in the cemetery.

Leslie Scott of Florence stated that as a social worker for the State of Alabama she took an oath to advocate for social justice. She further stated that this monument represents inequality and white supremacy and does not belong where it is.

Will Trapp of Florence stated that in the book of Romans we are instructed to live in peace with one another and we have a wonderful opportunity to show our fellow citizens that we do not support systemic racism as this statue symbolizes more pain than we can understand. He further stated that it is not violent or disgraceful or erasing history to move the monument to a more fitting location at the soldier's rest in the cemetery.

Tira Wages of Florence congratulated the Commission on being in the position they are in to be a part of this decision that can change our community as we progress and finally get it right.

Joel Peoples, a local business owner, stated that since we have more information and funds have been made available to pay the fine, we have a legal and moral responsibility to break the law and take down the monument.

There being no further business to come before the Commission and upon a motion made by Commissioner Garner and seconded by Commissioner Parker, the meeting was duly adjourned until the next regular meeting subject to call.
