The scanner will minimize contact with inmates as COVID-19 concerns continue and the cost of one hundred seventy-five thousand twenty-five dollars and twenty-four cents will be submitted for reimbursement through COVID grant funding and any budget amendment needed for this purchase is herein approved. There being no further discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Garner to authorize a resolution to approved a Right-of-Way Agreement for a federal aid project between the State of Alabama and the Lauderdale County Commission regarding a bridge replacement on County Road 16 over Cypress Creek. The project is estimated at a cost of two hundred fifty-five thousand twenty-five dollars consisting of eighty percent MPO funds and twenty percent County funds and any budget amendment needed for this project is herein approved. Commission Hackworth stated that he would abstain from voting due to the close proximity of this project to his family.
