The Lauderdale County Commission convened at the Lauderdale County Courthouse in the City of Florence, Alabama, at 5:00 p.m. on the 25th day of January, 2021. Chairman Danny Pettus, upon declaration of a quorum being present, opened the meeting for the transaction of business.

The invocation and Pledge of Allegiance were delivered by Commissioner Garner.

Public Comments on Agenda Items: None

Commissioner Parker moved, seconded by Commissioner Hackworth that all items listed on the regular business agenda be approved for immediate consideration. There being no discussion and upon a vote taken, motion unanimously approved. Agenda is herein recorded and made a part of these minutes.

Commissioner Garner moved, seconded by Commissioner Holmes that the minutes of the last regular meeting of the Commission be approved for recording. There being no discussion and upon vote taken, motion unanimously approved.

Commissioner Holmes moved, seconded by Commissioner Hackworth to approve a resolution to authorize COVID-19 Emergency Leave for County employees. The State of Alabama recently discontinued reimbursing the County for paying employees who miss work due to a COVID-19 diagnosis or the diagnosis of a member of their household. The Commission will continue paying these employees and not requiring them to use their own accrued time as long as it meets State guidelines regarding exposure timeline and required quarantine time necessary to allow them to return to work. Each case must be approved by the County Administrator with required documentation and this benefit may be discontinued at any time by the Commission or once there is no longer a declared state of emergency. Any budget amendment necessary is also approved. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Garner to approve a resolution to authorize the renewal of Bid 2020-7 "Gasoline & On-Road Diesel Fuel". The Lauderdale County Road Department has received written confirmation from Petroleum Traders and Tatum Oil for renewal of this bid. Both companies have agreed to continue the same terms, conditions and pricing provided in the original bids. The Commission approved the renewal of these contracts from March 1st through September 30th, 2021. The reason for the 6-month term is to allow this annual bid to expire at the end of the fiscal year in order to be consistent with all other annual Road Department bids. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Garner moved, seconded by Commissioner Holmes to appoint Ronnie Walton to the upcoming vacancy on the East Lauderdale Water Authority Board. Mr. Walton's term will begin March 1st, 2021, and run for six years, through March 1st, 2027. There being no discussion and upon a vote taken, motion unanimously approved.

Commissioner Parker moved, seconded by Commissioner Garner to authorize a request submitted by Rodney Pettus, License Commissioner, for one of his employees to take FMLA leave. The leave will begin January 8th, 2021, through April 4th, 2021. All necessary paperwork is in order for this request. There being no discussion and upon a vote taken, motion unanimously approved.

All invoiced bills were audited, allowed and ordered to be paid upon by a motion made by Commissioner Holmes and seconded by Commissioner Parker. There being no discussion and upon a vote taken, motion unanimously approved.
