Commissioner Parker moved, seconded by Commissioner Garner that all items listed on the regular business agenda be approved for immediate consideration. There being no discussion and upon a vote taken, motion unanimously approved. Agenda is herein recorded and made a part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Parker that the minutes of the last regular meeting of the Commission be approved for recording. There being no discussion and upon vote taken, motion unanimously approved.

Commissioner Garner moved, seconded by Commissioner Parker to approve a resolution to authorize the removal of a process regarding County inventory. Currently the County records inventory on physical index cards and this process is no longer necessary. The Commission approves to discontinue recording inventory on physical index cards as long as inventory records are maintained electronically according to the threshold limits for capital assets. Electronic records will continue to be maintained for certain items below the capital threshold limits, such as computer laptops, equipment requiring a title or County tag and other items deemed necessary by the County. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Garner to approve a resolution to authorize the transfer of property from the Lauderdale County Road Department to Lauderdale County Solid Waste Department. The Road Department has a surplus item it will be selling to the

Solid Waste Department. The item is a 1995 Ford L9000 Tractor Truck valued at two thousand five hundred dollars. The Commission approves the transfer of this property to Solid Waste. There being no discussion and upon a vote taken, motion approved. Resolution is herein recorded and made part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Parker to approve a resolution to authorize a donation of five thousand dollars to the Town of Waterloo for the upcoming Trail of Tears Commemorative Motorcycle Ride. The event is scheduled to occur in September 2021 and this donation will be paid for out of tourism. Any budget amendment needed is herein approved. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Garner to approve a resolution to authorize the removal of an inventory item from the Lauderdale County Board of Education inventory. The item is an outdated Hewlett Packard Server and the Commission approves this asset be removed from inventory and disposed of accordingly. There being no discussion and upon a vote taken, motion approved. Resolution is herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Hackworth to approve a resolution to authorize an increase in the monthly parking lot rental fee charged for those who park in the lot owned by the Lauderdale County Commission. The parking lot is located at the corner of Seminary and College Streets in Florence and renters are currently charged ten dollars per month, per space, for rental of parking spaces. The Commission approves to increase the monthly rent to twenty dollars per month, per space, effective June 1st, 2021. Commissioner Holmes stated that the intent for this increase is for improvements to be made to the parking lot. There being no further discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Garner to approve a resolution regarding the ongoing COVID-19 Coronavirus Pandemic. The State of Alabama recently discontinued a mask order and gathering restriction that have been in place due to COVID-19. The Commission recognizes the impact the Coronavirus has had on our community, our state, our nation and our world. The Commission continues to stress the importance of and encourages the use of facial coverings and the practice of social distancing as we alleviate mandates yet continue to be aware of the need for certain measures as we return to more normal activities. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Parker to approve a resolution to authorize a purchase for the Lauderdale County Road Department. The Road Department recently purchased a budgeted item from the State bid list from Coblentz Equipment. The 5711 Massey Ferguson Tractor package totaled one hundred twenty-two thousand one hundred twenty-one dollars and thirty-six cents and this purchase is approved by the Commission. Commissioner Hackworth and County Engineer, Eric Hill, discussed the functions and usage options of the tractor. There being no further discussion and upon a vote taken, motion approved. Resolution is herein recorded and made part of these minutes.

Commissioner Garner moved, seconded by Commissioner Holmes to approve a resolution to authorize a donation of four thousand dollars to the Town of Anderson for their upcoming Founder's Day Celebration scheduled for May 15th, 2021. The donation will be paid for out of tourism and any budget amendment needed is herein approved. There being no discussion and upon a vote taken, motion unanimously approved. The general and medical professional liability coverage for this event has an annual cost of seventeen thousand thirty-nine dollars and fifty cents. The Commission approves an insurance policy through J. Smith Lanier with Landmark American for the duration of the event and any budget amendment needed is herein approved. Commissioner Holmes asked Lauderdale County EMA Director, George Grabryan, for an update regarding COVID-19 vaccinations at the clinic. Mr. Grabryan stated that we had to-date vaccinated three hundred eighty-three citizens at the mobile clinics. Commissioner Hackworth asked Mr. Grabryan to confirm the clinic schedule for the upcoming week and Mr. Grabryan stated that the clinic hours for the week ahead would be 8am to 3pm with both clinics operating on Tuesday, Wednesday and Friday and only Cornerstone operating on Thursday. There being no further discussion and upon a vote taken, motion approved. Resolution is herein recorded and made part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Holmes to approve a resolution to recognize Public Safety Telecommunications Week, April 11th, through April 17th. The Commission wishes to extend its appreciation and honor the value and accomplishments of those vital individuals who serve in Lauderdale County in the capacity of providing a lifeline to emergency responders in the field, law enforcement officers, firefighters and the citizens of our County. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Parker to reappoint Ben Maharrey to the Scope 310 Board with his term to continue and expire April 1st, 2027. There being no discussion and upon a vote taken, motion unanimously approved.

Commissioner Garner moved, seconded by Commissioner Holmes to reappoint two members of the Civil Services Board of Appeals - John Hicks, Jr. with his term expiring May 14th, 2024, and Gene F. Young with his term to expire April 14th, 2024. There being no discussion and upon a vote taken, motion unanimously approved.

Commissioner Hackworth moved, seconded by Commissioner Parker to reappoint Scott Haataja and Trent Jordan to the NACOLG Revolving Loan Board of Directors with their terms expiring May 26th, 2024. There being no discussion and upon a vote taken, motion unanimously approved.

She stated that the Probate office preferred to go with the price break quantity of one thousand at a cost of three hundred fifteen dollars. Commissioner Holmes motioned, seconded by Commissioner Parker to award the bid to Printers & Stationers. There being no discussion and upon a vote taken, motion unanimously approved. Bid is awarded to Printers & Stationers of Florence, Alabama. Bid tabulation sheet is recorded and made part of these minutes.

In compliance with bid laws of the State of Alabama, sealed bids were advertised for Bid 2021-7 "Bridge Repair on CR 259 over Greenbrier Branch". Bids were received and publicly read aloud on April 7th, 2021. Chairman Pettus asked Lauderdale County Road Department Engineer, Eric Hill, for his recommendation. Mr. Hill stated that Shotcrete of America of Florence submitted the lowest bid for the job at a cost of thirty-nine thousand five hundred dollars, which is within the budget. Mr. Hill further stated that Shotcrete is a responsible bidder and has performed good work for the county in the past and he recommends them for the job. Commissioner Holmes asked Mr. Hill how long the repair job would last in comparison to replacement. Mr. Hill stated that repairs on the bridge would last in excess of thirty years. Commissioner Holmes moved, seconded by Commissioner Parker to award the bid to Shotcrete of America. There being no further discussion and upon a vote taken, motion unanimously approved. Bid is awarded to Shotcrete of America of Florence, Alabama. Bid tabulation sheet is recorded and made part of these minutes.
