Public Comment Period:

James and Renee York of 1640 Lagrange Road, Leighton, Alabama, were present and Mr. York stated that he and his wife are currently staying in a recreational vehicle at Brush Creek Park and have been asked to leave by park management before their 30-day stay limit. He wanted to know why they would be asked to leave since they have broken no rules regarding stay times. Parks Manager, Tom Smith, stated that Mr. and Mrs. York were staying at the rent-free park in multiple RV's at alternating intervals and staying in the same location and surrounding area for a prolonged period of time and prohibiting others from enjoying the same location. Mr. York stated that he owned several RV's and was allowing his son to use one of them and their stays were not over 30 consecutive days in any one RV. There was some dispute over the arrival and departure times of Mr. York's vehicles and a discussion was held regarding how to make clear the intent of the 30-day stay and 7-day break required between visits. Commissioner Holmes stated that he appreciated the York's for bringing this misunderstanding to the attention of the Commission. Mr. Smith stated that new rules and regulations would be forthcoming and will be distributed to everyone currently staying at the park and will be given to any future visitors so that everyone may understand the responsibilities and limitations of staying at Brush Creek Park.

County Attorney, Chris Smith, advised the Commission to enter into Executive Session to discuss pending litigation since discussion of this pending litigation could be adversely affected by public disclosure of the content of such meeting. Upon a motion made by Commissioner Holmes and seconded by Commissioner Hackworth, the Commission went into Executive Session. After discussion, the Lauderdale County Commission did not reconvene.
