Vice-Chairman Joe Hackworth, upon declaration of a quorum being present, opened the meeting for the transaction of business.

The invocation and Pledge of Allegiance were delivered by Vice-Chairman Hackworth.

Awards and Presentations:

Vice-Chairman Joe Hackworth presented Senator Tim Melson and Representative Lynn Greer with plaques honoring their dedication and service to County Government in Alabama through house sponsorship and passage of Act 2021-348, expanding the use of excess county Solid Waste funds for the best interest of the public.

Public Comments on Agenda Items:

Lauderdale County Sheriff, Rick Singleton, stated that he had a comment about item 6 on today's Agenda – Resolution for Town of Anderson Contract. Mr. Singleton stated that Deputy McCrary, currently serving in this position, will run for Sheriff in the upcoming election and he wanted to make the Commission aware of limitations regarding his continuing to serve in this capacity once he qualifies to run for office. It was decided that the contract will be renewed and if there is a need to update the contract in the future it will be handled at that time.

Commissioner Parker moved, seconded by Commissioner Holmes that all items listed on the regular business agenda be approved for immediate consideration. There being no discussion and upon a vote taken, motion unanimously approved. Agenda is herein recorded and made a part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Parker that the minutes of the last regular meeting of the Commission be approved for recording. There being no further discussion and upon vote taken, motion unanimously approved.

Commissioner Holmes moved, seconded by Commissioner Parker to approve a resolution to authorize receipt of the first installment of American Rescue Plan Act funding in the amount of

nine million five thousand seven hundred sixty dollars and fifty cents and any budget amendment needed in the use of these funds. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Holmes to approve a resolution to authorize a request by the Reappraisal Department for a Budget Revision Request for fiscal year 2020-2021. This budget revision will be by line item only and shortages in Office Supplies and Telephone will be reconciled by excess funds in Legal Services. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Parker to approve a resolution to authorize a donation of four thousand dollars to the Town of Killen for the 2021 Killen Founders' Day scheduled for August 6th and 7th, 2021. This donation will be paid out of Tourism and any budget amendment needed is herein approved. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Parker to approve a resolution to authorize a contract with the Town of Anderson. The Lauderdale County Sheriff's Department contracts with the Town of Anderson to provide part-time law enforcement services. The Town of Anderson has renewed this contract beginning July 1st, 2021, through June 30th, 2022, and will renew automatically each year without notice of intent to not renew. There being no discussion and upon a vote taken, motion unanimously approved. Resolution and contract are herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Holmes to approve a resolution to authorize the schedule of fees set by the Lauderdale County Health Department for fiscal year 2021-2022 pursuant to Legislative Act 81-207. There being no further discussion and upon a vote taken, motion unanimously approved. Resolution and fee listing are herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Holmes to approve a resolution to authorize the FY 2021 County Rebuild Alabama Contractor Report regarding the use of Rebuild Alabama gas tax funds for FY 2021. There being no discussion and upon a vote taken, motion unanimously approved. Resolution and report are herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Parker to approve the reappointment of Darlene Ballard to the Florence-Lauderdale Port Authority Board effective immediately and expiring July 21st, 2026. There being no discussion and upon a vote taken, motion unanimously approved.

Commissioner Parker moved, seconded by Commissioner Holmes to approve the reappointment of Dr. Gilbert Melson to the Northwest Alabama Regional Airport Board. His new term will expire August 10th, 2024. There being no discussion and upon a vote taken, motion unanimously approved.

In compliance with bid laws of the State of Alabama, sealed bids were advertised for Bid LA 2021-8 "Two (2) Traction Elevator Upgrades". Bids were received and publicly read aloud on July 22nd, 2021. Vice-Chairman Hackworth asked Lauderdale County Administrator, Brenda Bryant, for her recommendation. Ms. Bryant stated that only one bid was received from Bagby Elevator Company. She recommends we award the bid to them at a cost of two hundred sixty-one thousand twenty dollars. Commissioner Parker motioned, seconded by Commissioner Holmes to award the bid. There being no discussion and upon a vote taken, motion unanimously approved. Bid is awarded to Bagby Elevator Company of Birmingham, Alabama. Bid tabulation sheet is recorded and made part of these minutes.

All invoiced bills were audited, allowed and ordered to be paid upon by a motion made by Commissioner Holmes and seconded by Commissioner Parker. Commissioner Parker asked Lauderdale County Engineer, Eric Hill, how many miles of county roads had been paved and Mr. Hill stated that they had currently paved approximately sixty-two thousand miles. There being no further discussion and upon a vote taken, motion unanimously approved.
