The Lauderdale County Commission convened at the Lauderdale County Courthouse in the City of Florence, Alabama, at 5:00 p.m. on the 8th day of November, 2021. The meeting was called to order by the Chairman of the Lauderdale County Commission, Danny Pettus. Upon roll call the following members answered present:

Chairman Danny Pettus, upon declaration of a quorum being present, opened the meeting for the transaction of business.

The invocation and Pledge of Allegiance were delivered by Commissioner Garner.

Awards and Presentations: Chairman Pettus presented a plaque of appreciation to Mike Melton with Coldwater Consultants for his tremendous support and dedication as Project Manager of the recent COVID-19 Vaccination Program with one thousand three hundred eighty-eight clinic hours provided in order to provide the citizens of Lauderdale County access to the three thousand one hundred ninety-eight vaccinations given during the term of the project.

Public Comments on Agenda Items: None

Commissioner Parker moved, seconded by Commissioner Garner that all items listed on the regular business agenda be approved for immediate consideration. There being no discussion and upon a vote taken, motion unanimously approved. Agenda is herein recorded and made a part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Garner that the minutes of the last regular meeting of the Commission be approved for recording. There being no discussion and upon vote taken, motion unanimously approved.

Commissioner Parker moved, seconded by Commissioner Holmes to approve a resolution to authorize a DEIA Policy for Lauderdale County. The Commission supports Diversity, Equity, Inclusion and Accessibility in the workplace and wants to ensure that personal or social circumstances are not obstacles to achieving one's potential. The Commission defines inclusion as a culture that connects each employee to the county organization and encourages collaboration, flexibility and fairness and leverages diversity throughout the county so that all individuals are able to participate and contribute to their full potential. The Commission would like to acknowledge its support with a DEIA Policy Resolution regarding this important aspect of working for Lauderdale County. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Parker to approve a resolution to award Bid LA 2022-2 "Handicap Voter Access for O.C. Eppes Community Center". The bid was tabled at a previous meeting of the Commission on September 27th due to the cost of the only bid received from Butler Construction for forty-five thousand four hundred dollars. By written confirmation, Butler Construction has reduced the price to thirty-four thousand five hundred dollars and the Commission would like to award the bid to Butler Construction. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Garner to approve a resolution to authorize its continued participation in the ACCA Workers' Compensation Self-Insurers Fund. Participation in this fund continues to be in the best interest of Lauderdale County and will allow the county to qualify for the 2024 Longevity Bonus given to active members of the Fund through fiscal year 2024. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Garner moved, seconded by Commissioner Parker to approve a resolution to authorize the Commission to host a legislative luncheon on November 16th, 2021. The luncheon will be held in order to discuss local and statewide economic development opportunities and funding with the state legislative delegation. The Commission approves this luncheon and an expenditure of up to two hundred fifty dollars in contingency funds and approves any budget amendment needed for this purpose. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Garner to approve a resolution to settle a pending lawsuit, Graham v. Lauderdale County et al case number CV-2014-900229. The lawsuit is regarding ownership of a private road that was once a county-maintained road. A one-time occurrence of improvements will be made to this road as part of this settlement. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Garner to approve a resolution to authorize a change order for Bid 2021-9 "Construction/Installation of Petroleum Product Handling System". Bid 2021-9 was awarded to Fueling Solutions, Inc. of Birmingham in May 2021 for one hundred ninety-two thousand eight hundred eighty-one dollars. During installation it was necessary to modify the location of the filling port for the above-ground storage tank, increasing the project total by three thousand four hundred seventy-eight dollars. The Commission approves this change order and any budget amendment needed. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Garner to approve a resolution to authorize an application for an ATRIP II project. The Commission would like to apply for a project to improve the intersection of County Road 61 (Middle Road) and U.S. Highway 72. This project would attempt to alleviate traffic congestion at this intersection and would be an improvement to County Road 61, allowing for the possibility of future improvements to this corridor. The Commission intends to use county funds to assist in the application selection process and may include the City of Florence as a joint partner in this endeavor. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Hackworth to approve a resolution to authorize the selling of two manufactured trailers. The self-contained manufactured trailers are 2021 Keystone Raptors and were used for COVID-19 mobile vaccination clinics throughout Lauderdale County. The project has ended and the Commission would like to sell the trailers through online bidding process with *govdeals.com*. There being no discussion and upon a

vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Parker to approve a resolution to authorize a budget amendment for EMA for fiscal year 2022. The budget amendment includes costs for several tower sites including property lease, utilities, maintenance and other related costs totaling thirty-eight thousand four hundred dollars. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Hackworth to approve a resolution to authorize rate increases for certain Solid Waste services. The fee for multiple residential garbage carts will increase from fifty-five dollars each to seventy-five dollars each. The disposal fee for tires will increase from eight-one cents each to one dollar each and from eighty-one dollars per ton to one hundred dollars per ton, effective November 9th, 2021. Commissioner Holmes stated that the cost to the county had gone up for these items and that is what prompted the increase. There being no further discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Garner to approve a resolution to authorize the official 2021 holiday schedule received from the Governor's office. Thanksgiving will be observed on Thursday and Friday, November 25th and 26th, 2021. Christmas will be observed on Friday, December 24th, 2021. New Year's Day will be observed Friday, December 31st, 2021. The courthouse will close on these days and all notification will be duly advertised. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Garner to approve a resolution to seek the opinion of the Attorney General of the State of Alabama regarding Constitutional Amendment 772. The Commission wishes to authorize the County Administrator and the County Attorney to seek an opinion regarding Constitutional Amendment 772 being utilized toward using COVID money for broadband expansion within Lauderdale County. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Parker to approve a resolution to authorize payment of invoiced bills prior to the next meeting of the Commission. Due to recent illness in the County Commission office, it will be necessary to postpone the processing and payment of bills until after today's meeting and before the next meeting of the Commission, set to occur November 29th, 2021. All invoiced bills for this time period are approved. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Garner to approve a resolution to authorize an amendment to the June 23rd, 2020, agreement with Volkert, Inc. of Birmingham for services in connection with the Lauderdale County Work Development Center project. Any budget amendment needed for this amendment is approved. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Garner moved, seconded by Commissioner Hackworth to approve a resolution to authorize an amendment to the April 16th, 2021, agreement with Goodwyn, Mills & Cawood of Huntsville for services in connection with the Lauderdale County Work Development Center project. Any budget amendment needed for this amendment is approved. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

In compliance with bid laws of the State of Alabama, sealed bids were advertised for Bid LA 2022-1 "Various Printing Jobs". Bids were received and publicly read aloud on November 8th, 2021. Chairman Pettus asked County Administrator, Brenda Bryant, for her recommendation. Ms. Bryant stated that bids were received from Herald Printing and Printers & Stationers. She recommended we award the bid for License Commission and Probate printed envelopes to the lowest bidder, Herald Printing, for two hundred twenty-three dollars and fifty cents for quantities of five thousand. She recommended we award the bid for License Commission window envelopes to the lowest bidder, Herald Printing, for two hundred forty-eight dollars for quantities of five thousand. She recommended we award the bid for Reappraisal business cards to the lowest bidder, Printers & Stationers, for nineteen dollars for a quantity of two hundred. Commissioner Parker motioned, seconded by Commissioner Garner to award the bid. There being no discussion and upon a vote taken, motion unanimously approved. Bid awarded to Herald Printing and Printers & Stationers, both of Florence, Alabama.

George Grabryan thanked the Commission for their support of the COVID mobile vaccination project and for acknowledging Mike Melton today in his management of the project.

Public Comment Period:

Nathaniel Simpson of 946 Kensington Place in Tuscumbia asked for an update on the county road repairs near Rock Church. Lauderdale County Engineer, Eric Hill, stated that he had met with a consultant regarding the method needed for this particular situation. Mr. Hill stated that the road would be elevated two feet and that staffing and equipment were being scheduled to get started on the process during November, weather permitting. Henry Simpson of 201 N Providence asked about the product that would be used and Mr. Hill stated that a grid-based structure would be used and he further explained the process and plan. Commissioner Parker stated that he felt good about the road repair resolving the roadway water issues that had damaged the existing road and Chairman Pettus thanked the church members for their attendance.

There being no further business to come before the Commission and upon a motion made by Commissioner Parker and seconded by Commissioner Hackworth, the meeting was duly adjourned until the next regular meeting subject to call.
