Truman Jones of Dowdy Lane in Florence read a statement regarding his frustration with the length of time that the County Road 16 bridge has been closed due to replacement and the length of the detour his teenagers must drive daily during this time.

Peggy Sue Richardson of County Road 170 in Killen asked about the more frequent appearance of airplane trails she is seeing in the sky and expressed her concern of chemicals being a result. Commissioner Brad Holmes stated that neighboring Northwest Alabama Regional Airport has a beacon that is used for guidance by airplanes coming to and from surrounding areas such as Memphis, Nashville and Atlanta, and this traffic is evidenced by those trails we see.

RESOLUTION

WHEREAS, the Lauderdale County Commission previously entered into agreements with the city of Florence and the town of St. Florian wherein Florence and St. Florian exercised subdivision regulations within their planning jurisdictions which are outside their corporate limits; and

WHEREAS, the legislature of Alabama passed Act no. 2021-297 which was signed into law by the governor amending §11-52-30 Code of Alabama 1975; and

WHEREAS, the amended code §11-52-30 (e)(1a) states: "If a County Commission has adopted subdivision regulations pursuant to chapter 24, those subdivision regulations shall apply to the development of subdivisions within the planning jurisdiction of a Municipal Planning Commission outside the corporate limits of a municipality, and shall be regulated and enforced by the County Commission in the same manner and to the same extent as other subdivision development governed by the county's subdivision regulations."; and

WHEREAS, the Lauderdale County Commission, after the passage of the above referenced code amendment, wishes to end its agreement for subdivision regulation within the planning jurisdictions of the city of Florence and the town of St. Florian, outside their corporate limits, and enforce the county's subdivision regulations in all areas outside the corporate limits of Florence and St. Florian; and

WHEREAS, the Lauderdale County Commission states that the assumption of subdivision regulations outside the corporate limits of the city of Florence and the town of St. Florian and all other unincorporated areas of Lauderdale County is in the best interest of the citizens of Lauderdale County.

NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

- A. The agreements between the Lauderdale County Commission and the city of Florence and the town of St. Florian regarding subdivision regulation within Florence and St. Florian's planning jurisdiction and outside their corporate limits, shall be terminated six months after the date of the adoption of this resolution.
- B. Pursuant to this resolution and Act no. 2021-297, the County Commission does hereby officially give notice of the termination of said subdivision regulation agreements with the city of Florence and the town of St. Florian and does herby give notice to the city of Florence and the town of St. Florian that the County Commission shall begin subdivision regulation in all areas outside the corporate limits of the city of Florence and the town of St. Florian beginning six months after the date of the passage of this resolution.
