Chairman Danny Pettus, upon declaration of a quorum being present, opened the meeting for the transaction of business.

The invocation and Pledge of Allegiance were delivered by Commissioner Hackworth.

Awards and Presentations:

Chairman Pettus asked DeAnna Tidwell, Victim Services Director, to come forward on behalf of the Lauderdale County District Attorney's Office to accept a resolution commemorating National Crime Victims' Rights Week April 24th through 30th, 2022. Chairman Pettus stated that Lauderdale County is committed to provide a victim service and criminal justice response that assists all victims of crime during this week of observance and throughout the year. Our sincerest gratitude and appreciation for community members, victim service providers and criminal justice professionals who are committed to improving our response to all victims of crime so they may find relevant assistance, support, justice and peace.

Public Comments on Agenda Items: None

Commissioner Holmes moved, seconded by Commissioner Parker that all items listed on the regular business agenda be approved for immediate consideration. There being no discussion and upon a vote taken, motion unanimously approved. Agenda is herein recorded and made a part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Garner that the minutes of the last regular meeting of the Commission be approved for recording. There being no discussion and upon vote taken, motion unanimously approved.

Commissioner Parker moved, seconded by Commissioner Holmes to approve a resolution to acknowledge National Public Safety Telecommunicators Week. Public Safety Telecommunicators provide an essential service to Lauderdale County each and every day as the first line of communication to all citizens as they dispatch responders to their calls for

assistance. The second week in April is designated as National Public Safety Telecommunicators Week to honor those professionals who provide a lifeline to those in need. The Commission declares the week of April 10th through the 16th, 2022, as Public Safety Telecommunicators Week. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Hackworth to approve a resolution to authorize an appropriation for the Florence-Lauderdale Coliseum. Lauderdale County and the City of Florence jointly own the Florence-Lauderdale Coliseum. The city recently entered into contracts for necessary renovations to the coliseum at a cost of sixty-one thousand nine hundred sixty-five dollars. The county would like to appropriate funds to the city to cover half this total. The Commission approves an appropriation of thirty thousand nine hundred eighty-two dollars and fifty cents from the general fund for these renovations. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Parker to approve a resolution to authorize the Absentee Elections Manager to appoint clerical assistants as Absentee Elections Clerks. These clerks will aid in the upcoming elections for 2022. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Garner to approve a contract with Porter-Higginbotham Engineering of Fayette, Alabama, for underwater bridge inspections. The Commission approves and expenditure of ten thousand six hundred fifty dollars for underwater bridge inspections that are due for six bridges in the county. There being no discussion and upon a vote taken, motional unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Garner moved, seconded by Commissioner Hackworth to appoint Wesley Puckett to a vacancy on the Department of Human Resources board. This appointment is effective immediately and expires September 1st, 2025. Commissioner Holmes stated that he abstains from this vote. There being no further discussion and upon a vote taken, motion approved.

Commissioner Hackworth moved, seconded by Commissioner Holmes to reappoint Courtney Putman to the Agri-Business & Farmer's Market Board effective immediately and expiring April 8th, 2025. There being no discussion and upon a vote taken, motion unanimously approved.

Commissioner Garner moved, seconded by Commissioner Hackworth to appoint Nancy Gonce to the Lauderdale County Regional Library Board. This appointment fills a vacancy on the board effective April 8th, 2022, through April 8th, 2025. This is a joint appointment with the City of Florence and will be contingent on their passing a like resolution for this appointment. There being no discussion and upon a vote taken, motion unanimously approved.

Commissioner Holmes moved, seconded by Commissioner Garner to approve an out-of-state travel for Sheriff Rick Singleton. Sheriff Singleton and Deputy Richard Richey will be travelling to Kansas City, Missouri, for the National Sheriff's Conference June 26th through 30th, 2022. There being no discussion and upon a vote taken, motion unanimously approved.

Commissioner Garner moved, seconded by Commissioner Hackworth to approve FMLA requested by EMA Director, George Grabryan, for one of his employees. Leave will be effective March 21st through April 4th, 2022 and all paper work is in order for this leave. There being no discussion and upon a vote taken, motion unanimously approved.

Commissioner Parker moved, seconded by Commissioner Hackworth to approve an active miliary duty extension requested by Sheriff Rick Singleton for one of his employees. Leave will be extended from March 26th, 2022, to Mary 24th, 2022. There being no discussion and upon a vote taken, motion unanimously approved.

Bids for LA 2022-1 "Various Print Bids" were received, publicly opened and read aloud on April 8th, 2022. Chairman Pettus asked County Administrator, Brenda Bryant, for her recommendation. Ms. Bryant stated that two bids were received and she recommends the bid be awarded to the lowest bidder, Printers & Stationers, for Reappraisal Property Change Forms at a cost of one hundred sixty-three dollars for a quantity of two thousand with no price break accepted for larger quantities. Commissioner Holmes moved, seconded by Commissioner Garner to award the bid. There being no discussion and upon a vote taken, bid awarded to Printers & Stationers of Florence, Alabama.
