The Lauderdale County Commission convened at the Lauderdale County Courthouse in the City of Florence, Alabama, at 5:00 p.m. on the 23rd day of May, 2022. The meeting was called to order by the Chairman of the Lauderdale County Commission, Danny Pettus. Upon roll call the following members answered present:

Chairman Danny Pettus, upon declaration of a quorum being present, opened the meeting for the transaction of business.

The invocation and Pledge of Allegiance were delivered by Commissioner Holmes.

Awards and Presentations: None

Public Comments on Agenda Items: None

Commissioner Hackworth moved, seconded by Commissioner Parker that all items listed on the regular business agenda be approved for immediate consideration. There being no discussion and upon a vote taken, motion unanimously approved. Agenda is herein recorded and made a part of these minutes.

Commissioner Parker moved, seconded by Commissioner Garner that the minutes of the last regular meeting of the Commission be approved for recording. Commissioner Holmes abstained from voting since he was absent from the previous meeting. There being no discussion and upon vote taken, motion approved.

Commissioner Holmes moved, seconded by Commissioner Parker to approve a resolution to authorize the purchase of property formerly known as Wells Fargo Bank located at 102 Dr. Hicks Boulevard in the City of Florence. The property will be purchased for two million four hundred ten thousand dollars and will be used by the Florence-Lauderdale Emergency Management Agency. The Commission authorizes Chairman Danny Pettus to execute a purchase agreement and any budget amendment needed for the purchase is herein approved. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Garner to approve a resolution to authorize a budget amendment for a previously approved grant. The Lauderdale County Solid Waste Department submitted a 2021 ADEM Grant application for the Lauderdale County Recycling Program. The previously requested ¾-ton pickup truck

has increased in price to fifty-six thousand dollars; thus, increasing the total cost to the county to twenty-four thousand dollars. Any budget amendment needed for this increase is herein approved. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Hackworth to approve a resolution to authorize a one-time lump sum payment to eligible Lauderdale County retirees as provided by Act 2022-229. The estimated cost is seventy-seven thousand four hundred eighty-six dollars and will be paid to eligible retirees in October 2022. Any budget amendment needed is herein approved. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Parker to approve a resolution to authorize the Lauderdale County Emergency Management Agency to partner with North Alabama Council of Local Governments (NACOLG) for assistance with Hazardous Mitigation Grant Program funding through the Federal Emergency Management Agency. The proposed projects associated with this grant will be community safe rooms and generators for multiple county locations with an estimated total cost of three million three hundred ninety-nine thousand dollars with the county share not to exceed twenty-five percent of project total and a fifty percent project management fee to NACOLG of one hundred sixty-nine thousand nine hundred fifty dollars. The Commission will enter into an agreement with Mike Melton as Project Manager of Coldwater Consultant to oversee and facilitate projects associated with this endeavor at a cost not to exceed eighteen thousand dollars. The Commission approves these expenditures and approves any budget amendment needed. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Garner to approve a resolution recognizing June 12th, 2022, the second Sunday in June, as Race Amity Day. The Towards E Pluribus Unum Initiative has invited communities across the United States of America to join in introspection and reflection on the beauty and richness of the diverse peoples of this great nation while reaching out with a spirit of amity toward one another and recognition of Race Amity Day as a worthy observance for our community. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Garner moved, seconded by Commissioner Hackworth to reappoint the entire Lauderdale County Cemetery Board. Members of the board include Dr. George Makowski, Kitty Cox, Lee Freeman, Bill Burke and Curtis Flowers. All appointments are effective immediately and will expire June 30th, 2024. Commissioner Hackworth stated that he appreciates the great service this board provides to the county and their willingness to serve on this board. There being no further discussion and upon a vote taken, motion unanimously approved.

Commissioner Garner moved, seconded by Commissioner Hackworth to reappoint Mike Curtis to the 911 Board in a joint appointment with the City of Florence. The appointment is contingent upon the city passing a like resolution for this position effective immediately and expiring June 6th, 2026. There being no discussion and upon a vote taken, motion unanimously approved.

Commissioner Holmes moved, seconded by Commissioner Parker to approve an FMLA request by EMA Director, George Grabryan, for one of him employees. Leave will be effective May 4th through May 30th, 2022, and all paperwork is in order for the leave. There being no discussion and upon a vote taken, motion unanimously approved.

Bids for LA 2022-14 "Microbial Identification System" were received, publicly opened and read aloud on May 20th, 2022. Chairman Pettus asked County Administrator, Brenda Bryant, for her recommendation. Ms. Bryant stated that one bid was received from Beckman Coulter at a cost of two hundred forty-six thousand two hundred seventy-nine dollars and she recommends we award the bid to Beckman Coulter. Commissioner Holmes stated that the equipment in today's bids will be used at North Alabama Medical Center and will be one hundred percent paid for with grant funding. Commissioner Holmes moved, seconded by Commissioner Garner to award the bid as recommended. There being no further discussion and upon a vote taken, bid awarded to Beckman Coulter of Brea, California.

Bids for LA 2022-15 "Ventilator System" were received, publicly opened and read aloud on May 20th, 2022. Chairman Pettus asked County Administrator, Brenda Bryant, for her recommendation. Ms. Bryant stated there were no bids received and this item would be re-bid.

Bids for LA 2022-16 "Blood Culture System" were received, publicly opened and read aloud on May 20th, 2022. Chairman Pettus asked County Administrator, Brenda Bryant, for her recommendation. Ms. Bryant stated that one bid was received from Cardinal Health at a cost of ninety-nine thousand two hundred ninety dollars and she recommends we award the bid to Cardinal Health. Commissioner Holmes moved, seconded by Commissioner Parker to award the bid as recommended. There being no discussion and upon a vote taken, bid awarded to Cardinal Health of Dublin, Ohio.

All invoiced bills were audited, allowed and ordered to be paid upon by a motion made by Commissioner Parker seconded by Commissioner Garner. There being no discussion and upon a vote taken, motion unanimously approved.

She expressed her concerns regarding the current ambulance service in the county having poor management and not having the necessary staffing and supplies required to adequately care for the citizens of Lauderdale County. As a former Commissioner herself, she understands the weight of this decision and challenged the current members to make the best decision for Lauderdale County.

Mayor Jimmy Glass of Anderson stated that he appreciated the efforts of EMA Director, George Grabryan, and the Commission for their work with the Hazard Mitigation Grant in providing much needed storm shelters to our communities.

Commissioner Parker stated that the concerns regarding the ambulance service bid will be addressed as discussions are held regarding this decision. Chairman Pettus stated that the board met recently regarding the bid and thorough discussions are being had regarding the known issues. Commissioner Holmes stated that the upcoming work session will provide further opportunity to discuss the issues and that he expects an information sheet of all bidders will be provided to aid in this decision-making process.
