Commissioner Hackworth moved, seconded by Commissioner Parker to approve a resolution to authorize renewal of a bid contract with BFI Waste Services dba Republic Services of Huntsville for Bid No. LA 2021-9 "Disposal of Solid Waste". By written confirmation, Republic Services has agreed to continue the current pricing provided in the original bid for a period of one year under the same terms and conditions state in the original bid contract. There being no discussion and upon a vote taken, motion unanimously approved. Resolution and agreement are herein recorded and made part of these minutes.

Commissioner Garner moved, seconded by Commissioner Hackworth to approve a resolution to authorize the sale of county property. Lauderdale County and the City of Florence jointly purchased property, 730 South Mitchell Boulevard in Florence. The property was not suitable for the planned relocation of the EMA/911 facility and the county wishes to convey its interest in the property to the City of Florence for a total purchase price of two hundred forty-one thousand five hundred twenty-three dollars. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Holmes moved, seconded by Commissioner Hackworth to reappoint Richard Collins to the Floodplain Review Board effective November 23<sup>rd</sup>, 2022, and expiring November 23<sup>rd</sup>, 2027. There being no discussion and upon a vote taken, motion unanimously approved.

Bids for Bid No. LA 2023-1 "Renovations to the Lauderdale County Government Building" were received, publicly opened and read aloud on October 11<sup>th</sup>, 2022. Chairman Pettus referred to County Administrator, Brenda Bryant, for her recommendation. Ms. Bryant stated that only one bid was received, from Brad Slater Construction, at a cost of nine hundred seventy-one thousand one hundred sixteen dollars and she recommend they be awarded the bid. Ms. Bryant further stated that a budget amendment would be necessary since this is over the budgeted cost anticipated for these renovations. Commissioner Parker moved, seconded by Commissioner Garner to award the bid as recommended. There being no discussion and upon a vote taken, motion unanimously approved. Bid awarded to Brad Slater Construction of Leoma Tennessee.

Bids for Bid No. LA 2023-2 "Chipping of Wood Waste" were received, publicly opened and read aloud on October 13<sup>th</sup>, 2022. Chairman Pettus referred to Solid Waste Manager, Tom Smith, for his recommendation. Mr. Smith stated that only one bid was received from Oakley Biomass, our current provider, at a cost of six hundred seventy-five dollars per hour. Commissioner Holmes moved, seconded by Commissioner Hackworth to
