Chairman Danny Pettus, upon declaration of a quorum being present, opened the meeting for the transaction of business.

The invocation and Pledge of Allegiance were delivered by Commissioner Joe Hackworth.

Commissioner Parker moved, seconded by Commissioner Black that all items listed on the regular business agenda be approved for immediate consideration. There being no discussion and upon a vote taken, motion unanimously approved. Agenda is herein recorded and made a part of these minutes.

Commissioner Garner moved, seconded by Commissioner Parker to approve a resolution for the Lauderdale County Commission to support the Lauderdale County Board of Education with a grant in the sum of \$14,800 to be used to train for a mental wellness program in Lauderdale County High Schools. A budget amendment will be in the grant program. There being no discussion, and upon a vote taken, motion was unanimously approved. Resolution is herein recorded and made a part of these minutes.

The Town of Rogersville will be holding their annual Summer Fest on July 8th, 2023, and the Lauderdale County Commission will be supporting this event with \$5000.00 out of the Tourism Fund as well. There will be a budget amendment put into the Tourism Fund. There being no discussion, and upon a vote taken, motion was unanimously approved. Resolution is herein recorded and made a part of these minutes.

Commissioner Garner moved, seconded by Commissioner Hackworth to approve a resolution for renewal in the ACCA Liability Fund for the calendar years January 1, 2024 through December 31, 2026. There being no discussion, and upon a vote taken, motion was unanimously approved. Resolution is herein recorded and made a part of these minutes.

Commissioner Garner moved, seconded by Commissioner Parker to approve a resolution renewing property, equipment, heavy vehicle, and cyber insurance with Marsh & McLennan Agency. This new policy will be effective beginning March 1, 2023. Any budget amendment that is needed will be authorized. There being no discussion, and upon a vote taken, motion was unanimously approved.
