The Lauderdale County Commission convened at the Lauderdale County Courthouse in the City of Florence, Alabama, at 5:00 p.m. on the 13th day of March, 2023. The meeting was called to order by Chairman, Danny Pettus. Upon roll call the following members answered present:

Chairman Danny Pettus, upon declaration of a quorum being present, opened the meeting for the transaction of business.

The invocation and Pledge of Allegiance were delivered by Commissioner Roger Garner.

Public Comments on Agenda Items: None

Commissioner Parker moved, seconded by Commissioner Black that all items listed on the regular business agenda be approved for immediate consideration. There being no discussion and upon a vote taken, motion unanimously approved. Agenda is herein recorded and made a part of these minutes.

Commissioner Garner moved, seconded by Commissioner Hackworth that the minutes of the last regular meeting of the Commission be approved for recording. There being no discussion and upon vote taken, motion unanimously approved.

Commissioner Hackworth moved, seconded by Commissioner Parker to approve the Lauderdale Solid Waste Departments purchase of a 2024 garbage truck per state bid contract from Houston Freightliner Inc. for three hundred eleven thousand nine hundred three dollars. This was a budgeted item. There being no discussion, and upon a vote taken, the motion was unanimously approved. Resolution is herein recorded and made a part of these minutes.

Commissioner Parker moved, seconded by Commissioner Black to approve a resolution requiring Lauderdale County employees covered by the county health insurance plans participation in an annual wellness screening. These screening will take place on Tuesday, April 12th from 12:30 pm - 4:00 pm at the Road Department, Wednesday, April 13th from 6:30 am - 8:30 am at the Solid Waste Department, and Wednesday, April 13th from 10:00 am - 2:30 pm at the County Commission Office. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made a part of these minutes.

Commissioner Garner moved, seconded by Commissioner Parker to approve the opening of two new accounts at First Metro Bank, the Pistol Permit Revenue Loss Fund, and the Opioid Settlement Fund. There being no discussion, and upon a vote taken, motion was unanimously approved. Resolution is herein recorded and made a part of these minutes.

Commissioner Parker moved, seconded by Commissioner Garner to approve the renewal of the contract with Flock Group Inc. for automatic license plate detection. This renewal contract will be for the term of twenty-four months, in the amount of five thousand dollars, annually. This contract will also include the purchase of two new cameras costing five-thousand dollars with an implementation fee of one thousand one hundred dollars. There being no discussion, and upon a vote taken, motion was unanimously approved. Resolution is herein recorded and made a part of these minutes.

Commissioner Black moved, seconded by Commissioner Parker to approve the purchase of flooring for the remodel of the 6th floor of the Government Building in preparation for the Lauderdale County Commission to move there. The purchase is being made from The Carpet Store, through the state BID site. All supplies that are included in laying flooring at the cost of forty-seven thousand eight hundred nineteen dollars and ninety cents, as well as labor for laying the floor in the amount of fourteen thousand six hundred eighty dollars. There being no discussion, and upon a vote taken, motion was unanimously approved. Resolution is herein recorded and made a part of these minutes.

Commissioner Garner moved, seconded by Commissioner Black to approve the resolution contributing one hundred seven thousand seven hundred fifty dollars in appropriation to pay for twenty-five percent of the cost of a water tank installation of a fire suppression system in order for the City of Rogersville to obtain a new Tractor Supply Store. The Lauderdale County Commission feels this will be a huge step for the City of Rogersville as well as helping Lauderdale County Schools with increased sales tax revenue. There being no discussion, and upon a vote taken, motion was unanimously approved. Resolution is herein recorded and made a part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Parker to approve the Lauderdale County Emergency Management Agency Director, George Grabryan to hire, Paulette Williams, a Grant Writer, to search and provide the necessary areas of a Federal Emergency Management Agency Emergency Operations Center Funding Program for Lauderdale County. Paulette Williams' compensation will be in the amount of seventy-five dollars per hour, not to exceed ten thousand dollars per calendar year, plus milage, and expenditures. There being no discussion, and upon a vote taken, motion was unanimously approved. Resolution is herein recorded and made a part of these minutes.

Commissioner Garner moved, seconded by Commissioner Black to approve the Lauderdale County Emergency Management Agency Director, George Grabryan, to hire John James as project manager to oversee implementation of the county's Hazardous Materials Emergency Preparedness Grant. John James' compensation will be for a total of seventeen thousand five hundred dollars, fourteen thousand dollars of that amount will be paid from an EMA grant and three thousand five hundred will come from the Lauderdale County Commission. There being no discussion, and upon a vote taken, motion was unanimously approved. Resolution is herein recorded and made a part of these minutes.

Commissioner Parker moved, seconded by Commissioner Hackworth to approve the following board members, Larry Gist to continue appointment on the Greenhill Water and Fire Protection Authority Board. This appointment began on March 1, 2023, and expire on March 1, 2029. Steve McEachron, whose board term expired on March 9, 2023 will continue his appointment on the Agri-Business and Farmers Market. His new term will expire on March 9, 2026. Anthony Holcolm's board membership on the West Lauderdale Water and Fire Protection Authority Board will begin immediately, and expire on March 1, 2029. There being no discussion, and upon a vote taken, motion was unanimously approved. Resolution is herein recorded and made a part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Black to approve FMLA leave for one employee in the Revenue Department, and one employee in the County Commission Department. Chairman, Danny Pettus referred to Brenda Bryant, County Administrator, who confirmed all medical paperwork is in order for both employees. There being no discussion, and upon a vote taken, motion was unanimously approved. Resolution is herein recorded and made a part of these minutes.

Road Department BIDS for 2023-11, to purchase a Trailer Mounted Bituminous Applicator for Pavement Markers, were received, opened, and publicly read aloud Monday, March 13, 2023. Chairman Pettus asked County Engineer, Eric Hill for his recommendation. Eric Hill mentioned Gulf Material Sales LLC. are an instate company, and they were also the lowest bidder. Commissioner Hackworth pointed out how close the bids were. Commission Parker moved and Commissioner Black seconded his motion to purchase the trailer from Gulf Materials Sales LLC.

All invoiced bills were audited and ordered to be paid upon by a motion made by Commissioner Black seconded by Commissioner Garner. There being no discussion and upon a vote taken, motion unanimously approved.

PROFESSIONAL SERVICES AGREEMENT

This agreement is between the Lauderdale County Commission (hereinafter referred to as "County") and John James, an individual (hereinafter referred to as "James").

SERVICES

The county needs a project manager to oversee implementation of the county's Hazardous Materials Emergency Preparedness Grant for the citizens of Lauderdale County. James has the expertise and experience to provide the necessary implementation of the county related functions/activities including: overseeing implementation of the county's Hazardous Materials Emergency Preparedness Grant, conducting a detailed commodity flow study of our major transportation routes to identify hazardous materials transported, meet with local port and industries to cover any questions from the study, complete a local report and a grant close out report, and make application for the next phase for the Local Emergency Planning Committee to foster the factors needed for our industry/sellers.

TERM AND RATE
