NOW THEREFORE BE IT RESOLVED THAT a local emergency now exists throughout said Lauderdale County; and

BE IT FURTHER RESOLVED that during the existence of said local emergency, the powers, functions and duties of the Director of Emergency Management and the Emergency Organization of this County shall be those prescribed by state law and resolutions of the County.

BE IT FURTHER RESOLVED that said state of emergency shall be deemed to exist for ninety days or until its termination is declared by the County Commission of Lauderdale County, Alabama.
