Commissioner Black moved, seconded by Commissioner Hackworth to approve replacing Heath Haddock, who wishes to leave the Riverbend Center for Mental Health board, with Miranda Crittenden. This is a six-year term, and will begin immediately. Her term will end on April 1st 2029. There being no discussion, and upon a vote taken, this board appointment is herein recorded and made a part of these minutes.

Commissioner Parker moved, seconded by Commissioner Black to approve a FMLA request for a Lauderdale County License Department employee. All medical paperwork is in order for this leave. There being no discussion and upon a vote taken, motion was unanimously approved.

Bids for Bid No. LA 2023-7 "Barn #2 Construction for Animal Services" were received, publicly opened and read aloud on Friday, April 14th, 2023. Commissioner Pettus referred to County Administrator, Brenda Bryant, for her recommendation. Brenda Bryant told the Commissioners the bid was in the amount of seventy-nine thousand nine-hundred twenty-five dollars. A motion was made by Commissioner Black, and seconded by Commissioner Garner. Chairman Pettus asked if there are any questions, and Commissioner Parker asked if anyone had inspected the construction of the first barn. Commissioner Hackworth said he had been to the first barn, and was pleased on how it was built. Chairman Pettus mentioned that the second barn is cheaper per square foot than the first one built. A vote was taken, but due to the fact the vote was not unanimous, County Administrator, Brenda Bryant called for a roll call vote.
