AMENDMENT No. 2

to

Standard Form of Agreement Between

OWNER AND CONSTRUCTION MANAGER

Construction Manager as Owner's Agent

For services in connection with the Project known as: Lauderdale County Work Development Center, dated June 23, 2020 by and between The Owner: Lauderdale County Commission, a Body Corporate and the Construction Manager, (hereinafter, referred to as the "CM"): Volkert, Inc.

WHEREAS, the original Agreement dated June 23, 2020 for services in connection with the Project known as: Lauderdale County Work Development Center was executed on or about June 23, 2020 And

Whereas, Amendment #1 dated November 3, 2021 reconciled the fee for Total Project Cost of \$20,000,000 on or about November 3, 2021 And

Whereas, the Owner and CM have agreed to amend the contract to a lump sum monthly fee for the duration of the project And

Whereas, the project has bid and been awarded with a completion date of April 30, 2025 with Owner move in scheduled for May and June 2025.

NOW THEREFORE this Amendment #2 adopts the following, and amends all previous Agreements and Amendments between the parties, as follows:

The Basic Services will be in accordance with the terms and conditions of The Standard Form of Agreement Between Owner and Construction Manager dated June 23, 2020 and Amendment #1 dated November 3, 2021; but with the exception of the following changes, which will modify, supersede, amend and control:

- 2.5.1.1 The Total Project Cost Budget: The Total Project Cost Budget established for the Project by the Owner is approximately thirty-two million dollars (\$32,000,000).
- 2. 8.2.1 Compensation for Basic Services: The Owner shall compensate the CM a monthly rate of \$35,000.00 for performing Basic Services described in Article 3, from July 2023 through June 2025. Total compensation shall be reconciled with actual Project Schedule during the course of the project promptly following formal Project Schedule adjustments by the Owner. If no formal changes to the Project Schedule are made during the course of the project, total compensation shall be reconciled at project completion when final Project Schedule is determined. The CM compensation shall be paid in equal monthly

installments over the total duration of CM services as defined in 5.2. Volkert has earned \$630,000 in fee during the first 36 months of the contract, starting in July 2020 and running through June 30, 2023 per the original contract and amendment #1. The remaining fee of \$840,000 will be billed in the amount of \$35,000 per month in months 37-60, starting in July 2023 and running through June 2025.

3. 5.2 The duration of the CM's Basic Services under this Agreement shall be 60 consecutive calendar months from the commencement date of the contract.

The Owner and Consultant agree to the terms of this Amendment as contained herein.

WIC Income Eligibility Guidelines 2023-2024

United States Department of Agriculture (USDA) WIC Policy Memorandum 2023-4, Publication of the 2023-2024 Special Supplemental Nutrition Program for WIC Income Eligibility Guidelines, was received by the State WIC Office on April 3, 2023. The new income eligibility guidelines will be implemented by the Alabama WIC Program on May 1, 2023, and will be effective until June 30, 2024, or until updated. The new guidelines are attached and will be available in the Document Library.

Please ensure a copy of the 2023 WIC Income Eligibility Guidelines is posted at each intake station for reference. The WIC Crossroads management information system is being updated to reflect the new income guidelines taking effect on May 1, 2023. We need your assistance in making sure all clinic staff conducting income assessments for Alabama's WIC Program are informed of the revision.
