The invocation and Pledge of Allegiance were delivered by Chairman, Danny Pettus.

Chairman, Danny Pettus stated that item number eleven on the agenda will be removed, as discussed in the work session that preceded the meeting.

Commissioner Hackworth moved, seconded by Commissioner Black that all items listed on the regular business agenda be approved for immediate consideration. There being no discussion, and upon a vote taken, motion was unanimously approved. Agenda is herein recorded, and made a part of these minutes.

Commissioner Nix moved, seconded by Commissioner Garner that the minutes of the last regular meeting of the Commission be approved for recording. There being no discussion, and upon vote taken, motion was unanimously approved.

Commissioner Nix moved, seconded by Commissioner Black to approve hiring 2 full-time deputies for the Lauderdale County Sheriff Department, and any budget amendment needed. There being no discussion, and upon a vote taken, motion was unanimously approved. Resolution is herein recorded, and made a part of these minutes.

Commissioner Garner moved, seconded by Commissioner Hackworth to grant the exemption of County Sales and use taxes on non-commercial purchases related to severe weather preparedness during the last full weekend of February 2025. There being no discussion, and upon a vote taken, motion was unanimously approved. Resolution is herein recorded, and made a part of these minutes.

Commissioner Nix moved, seconded by Commissioner Garner to approve The Fiscal Year 2024/2025 Lauderdale County Rebuild Alabama Annual Report. This report will be attached to these minutes. There being no discussion, and upon a vote taken, motion was unanimously approved. This Resolution is herein recorded, and made a part of these minutes.

Commissioner Black moved, seconded by Commissioner Hackworth to approve Reimbursing the Solid Waste Department account for expenses incurred for entry in the Florence Christmas Parade. There being no discussion, and upon a vote taken, motion was unanimously approved. Resolution is herein recorded, and made a part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Nix to support legislation in favor of increasing yearly compensation by twenty-four thousand dollars for the Chief District Attorney and three Assistant District Attorneys in Lauderdale County. There being no discussion, and upon a vote taken, motion was unanimously approved. Resolution is herein recorded, and made a part of these minutes.

Commissioner Garner moved, seconded by Commissioner Black agreeing to write a letter of support for NACOLG while they apply for 5311 funds that will allow NACOLG to be able to continue operating public transportation in the rural areas of Colbert, Franklin, Lauderdale, Marion, and Winston Counties for fiscal year 2026. There being no discussion, and upon a vote taken, motion was unanimously approved. Resolution is herein recorded, and made a part of these minutes.

Commissioner Nix moved, seconded by Commissioner Black approving to make a correction to the Chief District Attorney's salary due to an oversight brought to the Commission's attention by District Attorney, Chris Connolly. This correction has been made for future pay, and backpay was given to the Chief District Attorney dated back to when she began working in 2017. There being no discussion, and upon a vote taken, motion was unanimously approved. Resolution is herein recorded, and made a part of these minutes.

Commissioner Garner moved, seconded by Commissioner Hackworth to approve repairing a 2003 Caterpillar Grader #415 for fifty thousand dollars at Thompson CAT in Tanner, Alabama for the Lauderdale County Road Department. There being no discussion, and upon a vote taken, motion was unanimously approved. Resolution is herein recorded, and made a part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Black agreeing to close the ARPA Revenue Reduction Fund account at Farmers and Merchants Bank. This account is no longer needed due to not having incoming funds for the account. There being no discussion, and upon a vote taken, motion was unanimously approved. Resolution is herein recorded and made a part of these minutes.

Commissioner Black moved, seconded by Commissioner Nix approving the removal of a list of assets from County inventory. This list will be included in the minutes. There being no discussion, and upon a vote taken, motion was unanimously approved. Resolution is herein recorded and made a part of these minutes.

Bids for 2025-6 "Truck Cab and Chassis" (3) were opened on Tuesday, January 7<sup>th</sup>, 2025. Chairman, Danny Pettus referred to Lauderdale County Engineer, Eric Hill for his recommendation. Mr. Hill recommended the bid go to only bidder, Donohoo Chevrolet. Mr. Hill stated that this bid was less than what the budgeted amount was for the Truck Cab and Chassis. Commissioner Nix moved, seconded by Commissioner Black to approve. There being no further discussion, and upon a vote taken, motion was unanimously approved. Bid is herein recorded, and made a part of these minutes

Commissioner Garner moved, seconded by Commissioner Nix to reappoint Barry Auchly to the Northwest Regional Airport Board. His new term expiration date will be January 2, 2028. There being no further discussion, and upon a vote taken, motion was unanimously approved. This board reappointment is made a part of these minutes.

Commissioner Garner moved, seconded by Commissioner Hackworth to approve Family Medical Leave of Absence for one employee in the County Commission Department. Chairman Pettus referred to Brenda Bryant to elaborate on the matter, and she stated all the paperwork is in order for the employee. There being no further discussion, and upon a vote taken, motion was unanimously approved.

#### RESOLUTION

WHEREAS, during its 2012 Regular Session, the Alabama Legislature enacted Act 2012-256 effective July 6, 2012 which provides an exemption of the state sales and use tax for certain non-commercial purchases related to severe weather preparedness, for the last full weekend in February for each year thereafter; and

WHEREAS, Act No. 2012-256 authorizes the County Commission to provide for an exemption of County sales and use taxes for purchases of items covered by the Act during the same time period in which the state sales and use tax exemption is in place, provided a resolution to that effect is adopted at least thirty days prior to its effective date; and

WHEREAS, the Code of Alabama 1975, §11-51-210(e) requires that the County Commission notify the Alabama Department of Revenue of any new local tax or amendment to an existing local tax levy at least 30 days prior to the effective date of the change; and

WHEREAS, the exemption of certain County sales and use taxes for the last full weekend of February, 2025 is an amendment to the County's sales and use tax levy warranting notice to the Alabama Department of Revenue as provided in Code of Alabama 1975 §11-51-210(e).

NOW THEREFORE BE IT RESOLVED by the Lauderdale County Commission that it does herein grant the exemption of County sales and use taxes on purchases covered by Act No. 2012-256 during the last full weekend of February, 2025, beginning at 12:01 a.m. on Friday, February 21<sup>st</sup>, 2025, and ending at 12:00 midnight on Sunday, February 23<sup>rd</sup>, 2025.


