REPAIR WORK ON KENWORTH DUMP TRUCK

I. INTRODUCTION:

The Lauderdale County Commission is seeking sealed bids on repair work for a 2025 Kenworth T880 Dump Truck, VIN: 1NKZX4TX2SJ134247 that was damaged when it overturned while dumping material.

II. SPECIFICATIONS:

A. This bid is for all parts and labor to do the following:

To include but not limited to inspection, frame and body repairs, mechanical component replacement, and restoration of the dump truck to a safe and fully operational condition in accordance with Kenworth reusability guidelines and specifications. Bidders must provide a detailed estimate and proposed repair timeline.

Repairs includes the following:

- Remove and repair hood
- Replace left side door
- Replace left side aperture
- Replace rear panel assembly
- Replace roof assembly
- Replace interior trim as needed
- Paint all repaired and replaced items as needed
- Pull oil pan and inspect bearings
- Replace damaged exhaust components
- Overhaul cooling module
- Reinstall driveshaft with new strap kit
- Diagnose and clear codes
- Check all fluid levels
- Set up and measure frame with gauges
- Replace bed lift cylinder
- Replace dump body (option 1)
- Repair dump body (option 2)
- Wash

The repairs listed are a minimum. Bid price shall include any other repairs and replacement parts as required to restore the vehicle to a safe and fully operational condition.

B. All truck parts shall be genuine Kenworth parts or equivalent.

C. This price shall reflect exchange parts for all items where applicable.

D. This bid will have two lump sum bid options:

1.) Option 1 – Repair estimate lump sum to include replacing dump body.

2.) Option 2 – Repair estimate lump sum to include repairing dump body.

*note that existing bed is a Logan Corp. bed but an OX body equivalent would be acceptable.

E. Bidders shall provide any warranty information in the bid. Type and length of warranty shall be considered along with price in the consideration of the bids.

F. Bidders will be responsible for transporting the machine to and from the Lauderdale County Road Department office in Florence, Alabama at the bidder's cost.

G. This is a lump sum bid for all labor and parts necessary to perform the work.

H. Price, quality of product bid, general product reputation and delivery times shall be considered in awarding the bid. The Lauderdale County Commission may choose to exercise the 5% preference for local bidders as allowed in Alabama's bid law.

LAUDERDALE COUNTY COMMISSION – INSTRUCTIONS TO BIDDERS

- All bidders are to submit bids on bid forms furnished by the Lauderdale County Commission, which are enclosed with bid invitation. All bid forms are to be signed in all designated areas by an authorized officer of the firm submitting the bid.
- All bidders shall base their proposals on the exact schedule of equipment, materials or services specified herein. Alternates will not be considered unless they conform to specifications. An itemized list containing a breakdown of material and labor costs must accompany bid documents.
- Reference to manufactures, suppliers, catalog numbers, etc., is intended to set quality standards and does not exclude bids from others as long as quality standard and specifications are met. Offers of equal items shall state the brand and number or level of quality.
- Pictures, descriptions and specifications should accompany all bids when required. If samples are required, they shall be furnished free of cost to the Commission.
- All prices submitted on the proposal are to be delivered prices to the Lauderdale County Courthouse or designated site and shall not include any state or local sales tax, except those non-exempt taxes for certain materials as required under state law.
- All bidders must certify that they are an Equal Opportunity Employer and meet E-Verify Requirements with documentation as well as provide proof of Worker's Compensation as required by law.
- Should amount of bid exceed \$50,000, a bid bond in the amount of 5% of amount bid must accompany bid. A certified check will be accepted. If a check is submitted and you are not the bid winner, check will be returned with notification letter. If a check is submitted and you are the bid winner, check will be returned upon completion of project or receipt of goods.
- Any change orders increasing cost or extending delivery/completion date must be approved by the Lauderdale County Commission prior to becoming effective.
- Should a bidder find discrepancies or omissions in bid documents or should he be in doubt as to their meaning, he should immediately notify the County Administrator, in writing, who will send written instructions to all bidders.
