Commissioner Garner moved, seconded by Commissioner Black approving sponsoring Anderson Founders Day with four thousand dollars from the Tourism Fund. There being no further discussion, and upon a vote taken, motion was unanimously approved. This Resolution is herein recorded, and made a part of these minutes.

Commissioner Nix moved, seconded by Commissioner Garner agreeing to partner with other local organizations to host the 2025 Household Hazardous Waste Day as well as sponsoring this event with five thousand dollars from the General Fund. There being no further discussion, and upon a vote taken, motion was unanimously approved. This Resolution is herein recorded, and made a part of these minutes.

Commissioner Hackworth moved, seconded by Commissioner Black approving out of state travel for one employee from the Sheriff Department to Franklin, Tennessee, and one Revenue Department employee to Mt. Juliet, Tennessee. There being no further discussion, and upon a vote taken, motion was unanimously approved. This Resolution is herein recorded, and made a part of these minutes.

Commissioner Nix moved, seconded by Commissioner Hackworth approving paying three hundred ninety-nine dollars to the Shoals Chamber of Commerce for yearly membership fees. Commissioner Black moved, seconded by Commissioner Garner to approve entering into an agreement with Ingenuity to design a county website at a contracted price of ten thousand dollars from the Commission Account. There being no further discussion, and upon a vote taken, motion was unanimously approved. This Resolution is herein recorded, and made a part of these minutes.

Commissioner Garner moved, seconded by Commissioner Black to approve out of supporting SB 334 the redistribution of SEDA funds. The redistribution will be equal parts of sales tax collection put in by each county and calculated by month from the previous Colbert County fiscal year contributions. The excess of Lauderdale County's collection will be split fifty-five percent to the Lauderdale County Commission for economic development within the county and forty-five percent to the City of Florence for economic development within the city. Commissioner Garner stated that this is to make the contributions more equal. Upon a vote taken, motion was unanimously approved. This Resolution is herein recorded, and made a part of these minutes.

Commissioner Garner moved, seconded by Commissioner Nix agreeing to use H&N Construction, Inc. as well as nine thousand five hundred dollars from the Government Building budget to make improvements to the Commission Conference Room. Commissioner Hackworth stated that this is a much-needed increase of space. Upon a vote taken, motion was unanimously approved. This Resolution is herein recorded, and made a part of these minutes.

Statement of Work - 04 Website Development

This Statement of Work ("SOW") dated May 1, 2025 references and is incorporated within the Master Agreement dated October 1, 2017 and amended September 1, 2023 between the Lauderdale County Alabama Commission ("Lauderdale County") and Ingenuity, Inc. (Ingenuity), an Alabama corporation.

Services and License:

Ingenuity will leverage its Content Management Platform ("TeamCMP") and the necessary TeamCMP applications to redesign Lauderdale County's website based on the requirements included in Attachment 1 - Project Scope Document. Once completed and approved by Lauderdale County, this website will be published. During the development of this website, Ingenuity will integrate the necessary TeamCMP applications with TeamCMP. Upon publication of this website, Ingenuity will provide Lauderdale County a non-exclusive, perpetual, and royalty-free license to TeamCMP and a TeamCMP User's Manual. The integrated TeamCMP applications will be added to and incorporated within Lauderdale County's license of TeamCMP. This license shall be for Lauderdale County's exclusive use of TeamCMP, the TeamCMP applications and the TeamCMP User's Manual. Lauderdale County shall have full rights to modify and use TeamCMP, as long as it is only used for the Lauderdale County website. Lauderdale County shall not provide (and shall not allow any of its employees, contractors or agents to provide) TeamCMP, any TeamCMP applications, any TeamCMP source code, or the TeamCMP User's Manual to any other person or entity. Ingenuity shall retain all intellectual property rights and interests in TeamCMP and the TeamCMP applications on a worldwide basis, including (1) all ideas, designs, concepts, techniques, inventions, discoveries, and improvements, regardless of patentability, but including patents, patent applications, trade secrets, and know-how; (2) all works of authorship regardless of copyright ability but including copyrights and any moral rights recognized by law; and (3) all other similar rights.

Ingenuity will invoice Lauderdale County following the execution of this SOW - 04 for one half of the \$10,000 fixed price.
